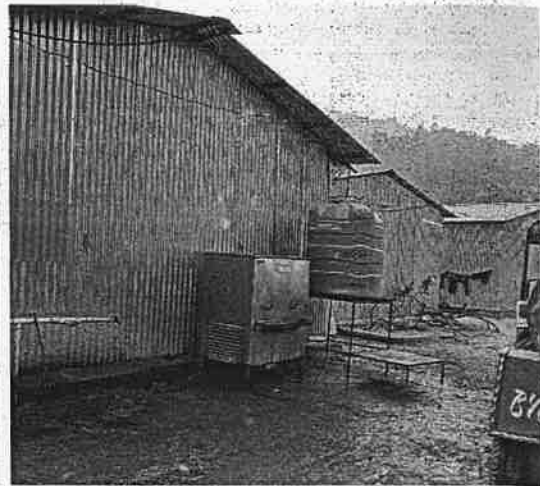

Appendix-A

Various components of the **Biodiversity Conservation and Management Plan** of the EIA/EMP report are being implemented as the project is being executed. The details are as under:

1. It is being ensured that noise levels don't go beyond 100dB(A), as can be seen in monitoring reports submitted with six-monthly compliance reports. This is being done by:
 - a. Regular maintenance of vehicles
 - b. Housing equipment permanently located at a site in noise absorbing structures
 - c. Mounting the vibratory equipment on anti-vibration mountings
 - d. Fitting silencers on machines with combustion engines, etc.
2. It has been proposed to develop a **Herbal Nursery near Village Sanotu** over an area of 0.50 ha. The issue has been taken up in the MDC meeting dated 18.01.2023 and the Chairman desired that project may explore possibility of development of herbal nursery in consultation with HPFD. Currently, the said land is being identified by HPFD.
3. It was also informed that an amount of Rs. 44.54 Million for afforestation and 19.7 Million for wildlife improvement and development has been kept in CAT plan.
4. Anti-poaching measures: fencing has been provided along the way to the dam site.



In addition, following activities and safeguards are being undertaken:

- a. Labor colonies are set up away from forest area/wilderness
- b. To minimize the pressure on forests and animal habitats for fuel,
 - i. Community kitchen has been made functional
 - ii. Cost for constructing 10 crematoria has been deposited

iii. LPG connections, solar emergency lights, solar cookers and solar water geysers have been provided for.

c. Movements and activities of laborers and associated workers is monitored to avoid disturbance in habitat of wild animals and birds.

The cost of Compensatory Afforestation and NPV, amounting to Rs.7.05 Cr. has already been deposited with CAMPA on 09.10.2019, prior to issuance of Stage-II Forest clearance.
