SJVN Foundation is pleased to present the sixth volume of its CSR Annual Report which is an effort to document the various activities being undertaken by the company to fulfil its Corporate Social Responsibility commitments.

CSR Vision

SJVN, as a responsible corporate citizen, has assimilated Corporate Social Responsibility (CSR) as an integral part of its business and is pledged to fulfill its social and environmental commitments for meaningful organizational growth. SJVN is of the firm belief that a part of its profits should essentially and regularly flow to the society and the stakeholders in terms of the government guidelines.

CSR Mission

SJVN is pledged to fulfil its social and environment commitments; because we know that our growth is meaningful when we share it with society.

SJVN has formulated and adopted a well-designed CSR and Sustainability Policy which was initially framed as per CSR guidelines issued by the Department of Public Enterprises (DPE) and is being revised from time to time as per government guidelines. The current CSR and Sustainability Policy has been revised as per the provisions laid under the Companies Act, 2013, and the CSR (Corporate Social Responsibility Policy) Rules notified by the Ministry of Corporate Affairs (MCA) in pursuit of the aforesaid Act. Based on provisions of the aforesaid Act, the Annual CSR and Sustainability Budget provided is equal to 2% of the average of the preceding three years' net profit of the company and the plan is recommended by a board level Committee of Directors (COD) on CSR and approved by the Board. The CSR activities enumerated under Schedule VII of the aforesaid Act are the guiding principles for selection of CSR programs by a company. Following such principles, SJVN has framed its CSR programs on health and hygiene, education and skill development, women empowerment, infrastructure development, community development, sustainable development, promotion of culture, protection of heritage and sports, assistance during natural disasters, rural development, support to hospitals for COVID-19, RandD etc.





The CSR programs are being primarily executed in operational areas of SJVN in India viz. in Himachal Pradesh, Uttarakhand, Bihar, Gujarat and Maharashtra.

In order to implement and monitor the CSR and Sustainability programs in effective manner, the SJVN Board has approved a Trust registered as 'SJVN Foundation' comprising seven trustees. The Trust is headed by Director (Personnel). The trustees are senior officials from cross functional areas so as to infuse the required strategic direction to the CSR and sustainability programs. CSR AND SUSTAINABILITY BUDGET AND EXPENDITURE - OVERVIEW

Much before the government guidelines under the Companies Act 2013, SJVN had started formulating a defined budget for CSR and Sustainability activities in the year 2010-11. The budget provision over the years has increased about 13 times, from ₹4.5 crore in 2010-11 to ₹58.45 crore in 2021-22. The statutory budget has also increased from ₹4.5 crore in 2010-11 to ₹39.44 crore in 2021-22 while the actual expenditure has at times surpassed the statutory budget by up to 146.86 percent. Over the past 12 years, ₹352.80 crore has been spent on various activities of CSR. An overview of CSR and Sustainability Budget and Expenditure, since beginning i.e. year 2010-11 is as follows.

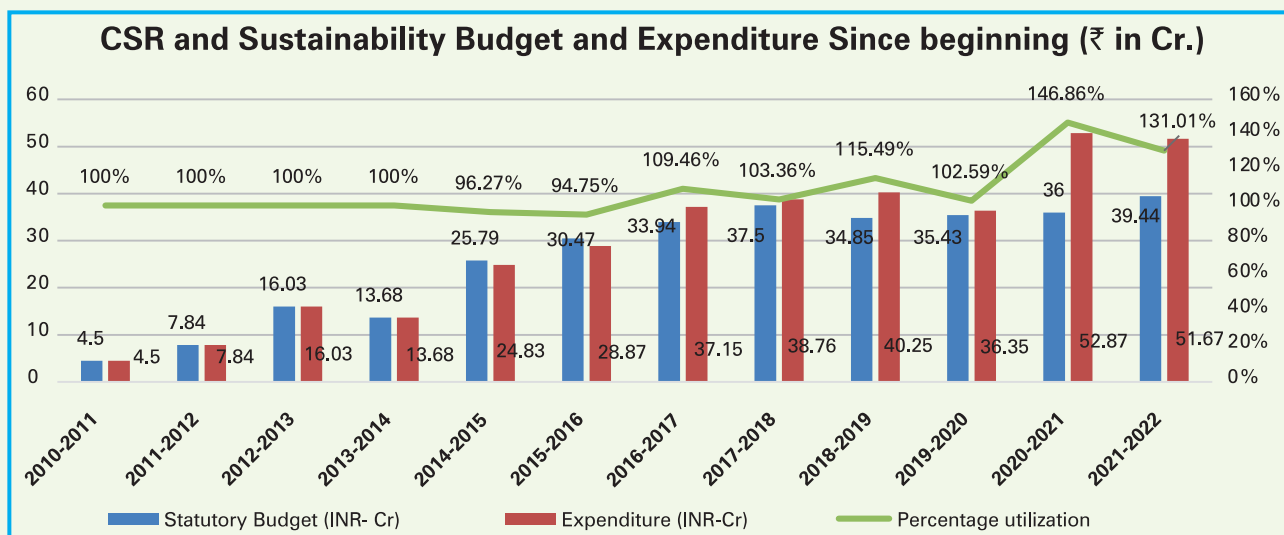

Based on the CSR and Sustainability budget procedures stipulated under the Companies Act 2013, the statutory budget for FY 21-22 i.e. 2% of average of last three years net profit was ₹36.00 Cr. However, the Board of Directors had approved a budget of ₹46.67 Crore for the year 2020-21. The expenditure for the year surpassed the statutory budget provision by more than 46% to ₹52.87 Crore and the details of expenditure as per the format specified by MCA is enclosed at **Annexure-A**.

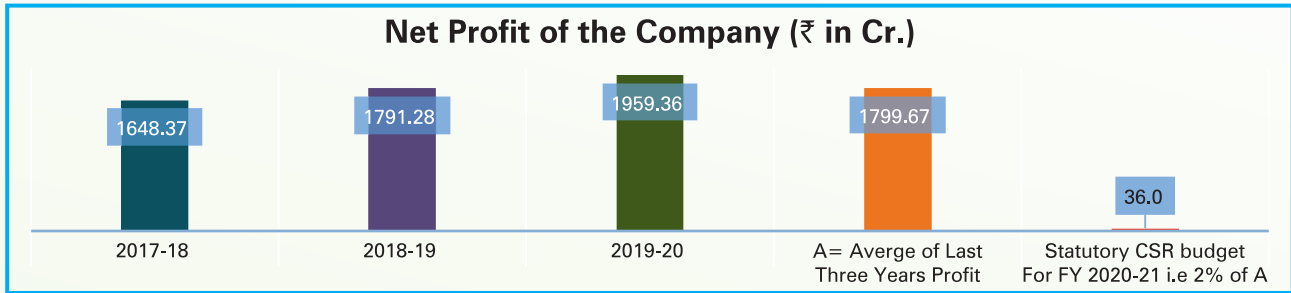

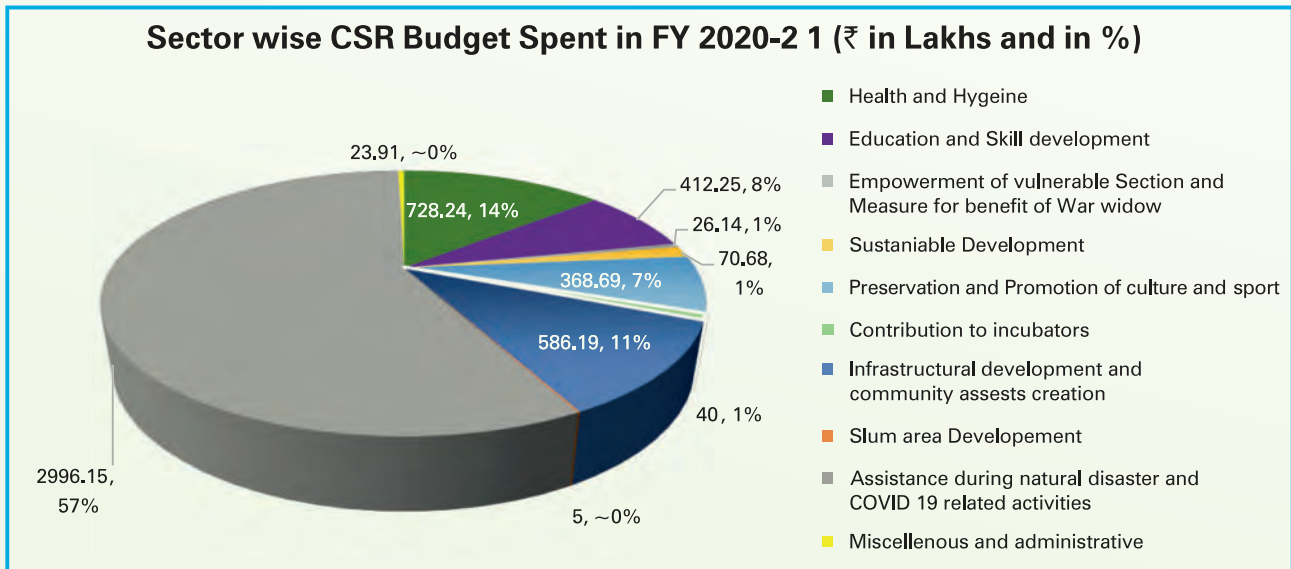

Net Profit of SJVN for the last three financial years is depicted below:

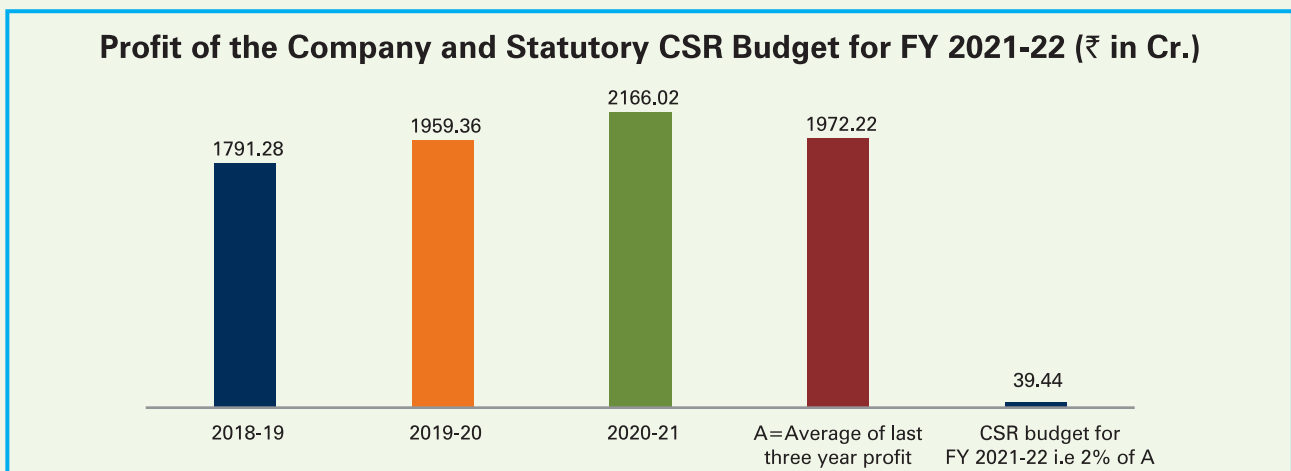

Based on the CSR and Sustainability budget procedures stipulated under the Companies Act 2013, the statutory budget for FY 21-22 i.e. 2% of average of last three years net profit was ₹39.44 Cr. However, the Board of Directors had approved a budget of ₹58.45 Crore for the year 2021-22. The expenditure for the year surpassed the statutory budget provision by more than 31% to ₹51.67 Crore and the details of expenditure as per the format specified by MCA is enclosed at **Annexure-B**.

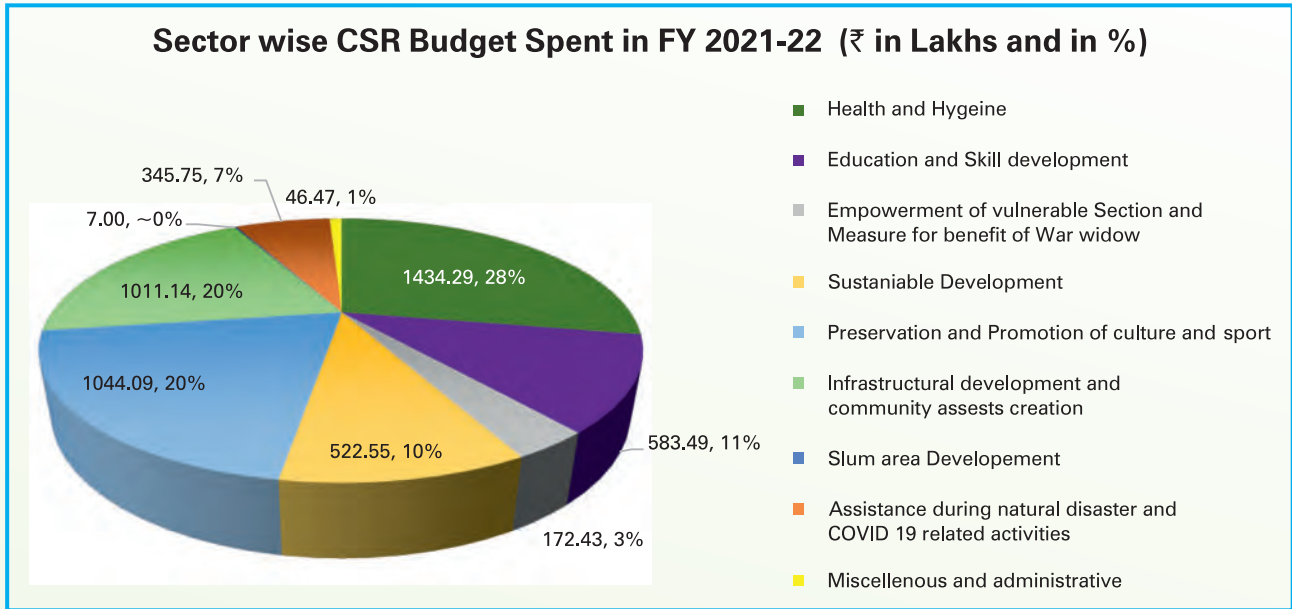

HEALTH AND HYGIENE

More than three decades ago when SJVN commenced construction at its flagship and the country's largest 1500 MW Nathpa Jhakri Hydro Power Station, the company found that the people living in the vicinity of the project suffered a lot due to lack of health and medical facilities. It was therefore in the very formative years of its inception that SJVN included the aspect of providing medical facilities to these people in one way or the other.

SJVN had initiated the Community Development Plan (CDP), since inception of its CSR policy through which it has been providing better health facilities to the local rural communities living in remote areas, devoid of health care services. It was also found that the people could ill afford the medicinal costs as well. SJVN had therefore taken the Community Health Initiative in a big way in the year 1995 and provided financial assistance of ₹800 Lakh (eight crore) to the Government of Himachal Pradesh for construction of a 200 bedded hospital in Mahatma Gandhi Medical Services Complex (MGMSC) at Khaneri near Rampur in Himachal Pradesh. Since then, medical services are being provided not only in the project affected areas but also in the adjoining districts like Shimla, Kinnaur and Kullu. The medical facilities include free medical care not only at the project hospitals but also through Mobile Medical Units being operated since the year 2000 to provide medical services at the door steps of the local communities. Details of various healthcare facilities and activities being extended by SJVN foundation for the locals are as under:

Satluj Sanjeevani Sewa (SSS) – Health Care at Door Steps

Satluj Sanjeevani Sewa has been launched on the occasion of SJVN's Silver Jubilee celebration in the year 2012. Through these mobile medical units SJVN provides free medical care at door steps to the poor and needy rural communities around its project areas in the states of Himachal Pradesh, Uttarakhand, Bihar and Maharashtra.

There are 14 Mobile Medical Units (MMUs) manned by qualified medical staff (MBBS doctors, pharmacists, social protection officers) and equipped with basic diagnostic test equipment operating in the defined areas. The services are being implemented through HelpAge India More than 10.5 lakh treatments have so far been provided through these MMUs since beginning while during the year 2021-22 itself the number of treatments extended was about 1.50 lacs. Details of cumulative treatments provided through these 14 MMUs till 31st March 2022 are detailed below:

The gender wise cumulative treatment provided by MMUs till date is shown in the bar chart given below for treatments given till **31st March 2022 (FY 2021-22)**:

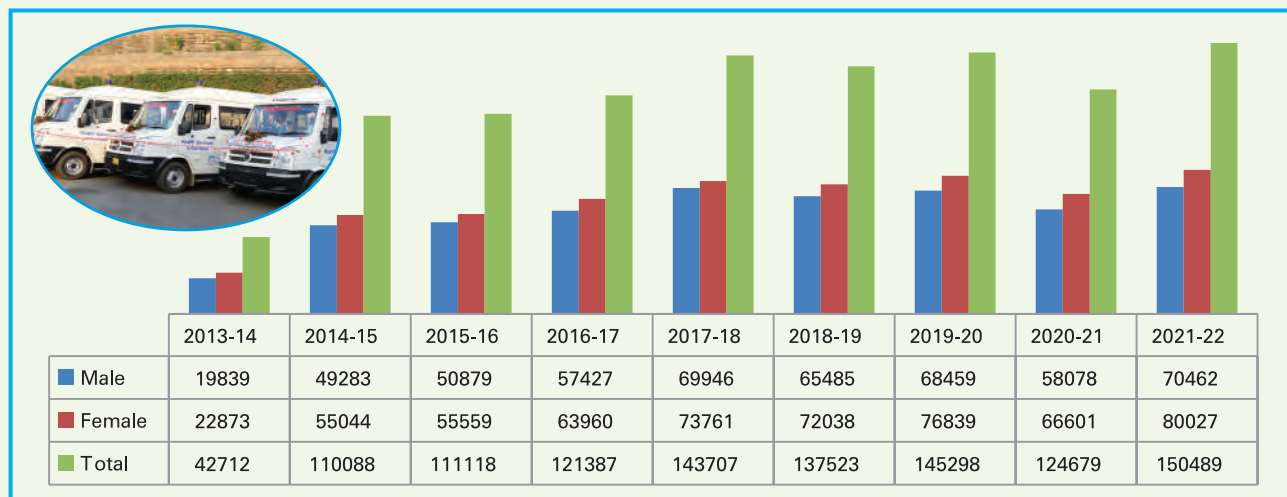

In addition to these 14 MMUs, one MMU is being operated by company doctors and Para medical staff in project affected areas of Rampur HPS also.



MMUs through Dhanush Foundation:

Buxar Thermal Power Project (BTPP) is operating six Mobile Medical Units in the project area through an NGO named Dhanush Foundation. The project authorities have entered into a MoU with Dhanush Foundation for Running and Maintenance of 06 MMUs under “Chikitsa Chikitsak Aapke Dwar” Program. The services of MMU were commenced with effect from 17.05.2021 and covered the areas of Brahampur, Buxar, Dumraon, Rajpur, Ramgarh and Dinara. During the period of its operations, the six MMUs provided treatments to 26516 patients consisting of 12227 females and 14289 males.

Health Campaign through Mobile Medical Units:

In addition to providing health care facilities to the people through Mobile Medical Units, SJVN Foundation has also been organising awareness sessions, General Health camps and specialized health camps in the project affected areas through HelpAge India. The details of General health camps and awareness session on COVID-19 organized in FY 2021-22 are as under:

Specialized Health camps through other Agencies

A. Through HelpAge India

To commemorate Azadi Ka Amrit Mahotsav SJVN Foundation organized eleven Specialized Health camps were organized through HelpAge India in Nathpa Jhakri HPS, H.P (01), Rampur HPS, H.P (04), Luhri HEP-1, H.P (01), Sunni Dam HEP, H.P (01), Dhaulasidh HEP, H.P (01), Jangi Thopan HEP, H.P (01), STPL, Buxar Bihar (01) and Naitwar Mori HEP, UK (01) at a financial implication of ₹17,80,287/-. The total number of persons benefitted from the program were more than 2500.

During the past nine years, as many as 226 specialized health camps were organized benefitting 71,092 people as per following details:

B. Through Global Cancer Concern India

Two Cancer awareness and screening camps at the cost of ₹3,91,400/- organized through Global Cancer Concern India benefitting 166 no of people. On 19.12.2021, the SJVN organized the camp at its NJHPS Auditorium Jhakri in which 82 persons comprising of 40 male and 42 females were screened for cancer. Similarly, on 27.03.2022, a screening camp was organized at Kala Gram Sujampur Tihra near DSHEP, Hamirpur site of SJVN in which 84 persons comprising of 46 male and 38 female screened for the Cancer related symptoms. The doctors also conducted awareness sessions on cancer, its symptoms and prevention. Printed and IEC material was also distributed among the people living in slum localities/village with a view to create awareness among the local people about the Cancer. In the above camps, out of the total 166 persons screened 06 patients were

found cancer suspect and further advised for immediate tests and treatment.

C. Through Open Hands Welfare Society

SJVN successfully conducted 03 Specialized health Checkup Camps in project affected areas of LHEP-1, Bithal, SDHEP, Sunni and DSHEP, Hamirpur in FY 2021-22 through Open Hands Welfare Society, Arki, Solan. A total of 338 Nos. people benefited consisting of 130 Males and 208 Females directly benefited from the camps. The health checkups of the beneficiary were done by Gyneocologist, orthopedics and pediatrician. Besides above, free medicines were distributed to the patients and special awareness sessions were also organized for women in which they were made aware about the cause and prevention of uterine cancer.

Ayurvedic Health Awareness Programs

As a measure to promote ancient Ayurveda based low-cost health-care system, SJVN has long been organizing health awareness-cum-lifestyle camps based on ayurvedic system of medicine. An NGO named Bhartiya Dharohar was roped in to organize the camps in Himachal Pradesh. Since Past 5 years, as many as 1430 ayurvedic health awareness camps were organized benefitting 159985 people as per the following details :

A total 200 ayurvedic camps were organized during FY 2020-21 at a financial implication of ₹75.44 Lakh. In FY 2021-22, a total of 400 camps have been organized around the project areas in Himachal Pradesh, Bihar and Uttarakhand at a financial implication of ₹145.12 Lakhs





Dental Care Services in Rampur HPS Area

Dental care is one health aspect which we often tend to ignore till the problem aggravates. Facilities of dental care are not very common in remote areas. In order to provide the services, SJVN has been operating a dental clinic at the Project Hospital of RHPS since 2014. The clinic is open to the people of project affected areas as well besides the company employees and members of their families. The patients are being given specialized treatment at the clinic ever since. Since the start of its operation till 31.03.2022, 7276 patients have been benefitted through this clinic while during the financial year 2021-22, itself more than 1372 patients have been treated. Details of patients treated during the year FY2021-22 are as under:

Physiotherapy Services

Physiotherapy helps people to get rid of suffering from injuries and body inability. Such services are hardly found in hilly areas where people have to be dependent on local faith healers who sometimes rather make the situation worse. One most common problem encountered in the hill regions is injuries sustained in falling down the slope, falling from a tree or paralytic conditions due to high blood pressure. Women often tend to damage their knee muscles due to grass cutting activities. The problem aggravates when it is ignored for longer periods. It was also found that people are not aware that such problems can be easily treated through physiotherapy. One major obstacle was non availability of a physiotherapy clinic in and around the company's projects. Seeing the urgent need, SJVN has established physiotherapy centers for local people at its Rampur Hydro Power Project Hospital at Bayal and at its Nathpa Jhakri Hydro Power Project Hospital at Jhakri. The details are as under:



A. Project Hospital- Rampur HPS

Specialized Physiotherapy facility was started at the Rampur Project's hospital more than four years ago. As per the experience, Dr Priyanka, Physiotherapist at the clinic shared that the facility has proved to be a big boon to the patients from the surrounding areas as patients hence were required to rush to the nearest hospital in Shimla and beyond for the treatment. During a span of 4 years, about 6500 patients suffering for arthritis, chronic backache, spinal or stiff neck problems, accident victims, sports injuries, post-operative patients needing exercising care have been treated at the centre.

During the financial year 2021-22, a total 1595 patients were benefitted from this facility as detailed below:

B. Project Hospital, Nathpa Jhakri HPS

Seeing the mass response to the physiotherapy clinic at Rampur Project’s hospital, the Physiotherapy services were established at Nathpa Jhakri Project’s hospital and started in the month of August 2021. Dr. Vijyeta, Physiotherapist at the hospital tells that the response to the clinic was so massive that during the initial days there would be more than 40 patients lining up for treatment. Accordingly, they had to regulate the patients in order to attend to them properly. A physiotherapy awareness camp too was organized in the project area where people were made aware of the benefits of physiotherapy for treatment of various ailments. During FY 2021-22, 2644 patients have been benefitted through these services till 31.03.2022 as detailed under:

Financial Support to Indian Association of Muscular Dystrophy

Muscular dystrophy is a group of inherited diseases that damage and weaken muscles over time. This damage and weakness are due to the lack of a protein called dystrophin, which is necessary for normal muscle function. Indian Association of Muscular Dystrophy (IAMD) is providing medical treatment to persons inflicted with muscular dystrophy disease the treatment of which is rarely available in India.

SJVN Foundation came forward to provide financial support of ₹5.78 Crore to the Indian Association of Muscular Dystrophy (IAMD) for construction of Integrated Muscular Dystrophy Centre at Solan (HP) named “Manav Mandir”. As on date, 1415 patients of muscular dystrophy have been provided treatments at the center since its inception. Further, out of 1415 patients as many as 849 patients have become one up in their physical status and have become successful in their lives.





Construction of Rotary Ashray Cancer Sarai

Patients of cancer from all over Himachal Pradesh come to IGMC, Shimla for treatment. Patients as well their attendants often suffered due to lack of lodging facilities in or around the hospital complex. SJVN Foundation came forward to extend financial support of ₹96.8 Lakhs for construction of one floor of Cancer Sarai developed by Rotary Charitable Trust near the IGMC cancer hospital for facilitating the stay of cancer patients and their attendants during their treatment. The Cancer Sarai has been completed and inaugurated by Chief Minister of Himachal Pradesh on 01.12.2021 and is in use by needy persons.



Health and Sanitation Facilities:

Buxar Thermal Power Project (BTPP), under the SJVN's CSR Initiatives for Healthcare Programmes and Swachhata Activities, has addressed the issue of non-availability of potable water to the people due to high contents of Arsenic metal in the soil of Buxar leading to contamination of underground water. More over six ambulances donated by SJVN as MMUs, equipped with diagnostic services (diagnostic kits), consumables (medicines etc) have been further upgraded. The project authorities are also in the process of providing sanitary napkins vending machines and incinerators at 20 Government schools. Installation of Water ATMs in the schools is also under process by the project authorities.

Construction of Senior Citizen Home at Palampur H.P

SJVN Foundation has sanctioned financial assistance of ₹2.00 crore for the construction of a Senior Citizen Home "Vishranti" at Vivekananda Medical Institute Palampur, District Kangra H.P. So far, an amount of ₹50 Lakhs has been released on 03.02.2022. The work is under progress. The Vishranti Bhawan, having a capacity of catering to the stay of 100 senior citizens would be equipped with all the facilities like sick room, medical check-up, library, audio-visual room, mess and security etc. and the assistance of medical and health services of the Senior Citizens living in Vishranti Bhawan will easily be taken care of by Vivekananda Medical Institute and Centre for Naturopathy.



Pathological laboratory equipments to MC Shimla

On the request of Municipal Corporation Shimla, a financial assistance of ₹32.91 Lakhs has been extended for procurement of pathological laboratory equipments for restarting its renowned laboratory started in the year 1905. The laboratory provides facilities to the general public for conducting almost twenty-five types of body tests at economical rates. As on 31st March, 2022 an amount of ₹16,43,992/- has been released to MC Shimla and procurement is under process.



Adoption of Five public parks of MC Shimla

The Commissioner, Municipal Corporation Shimla, Distt. Shimla (H.P.) raised a request for providing funds for development, repair and maintenance of the following five public parks in view of their popularity and footfall of the tourists and local public:

An MOU will be signed with MC Shimla for maintenance of public parks for a period of 03 years at an expenditure of ₹15.00 Lakhs per year.



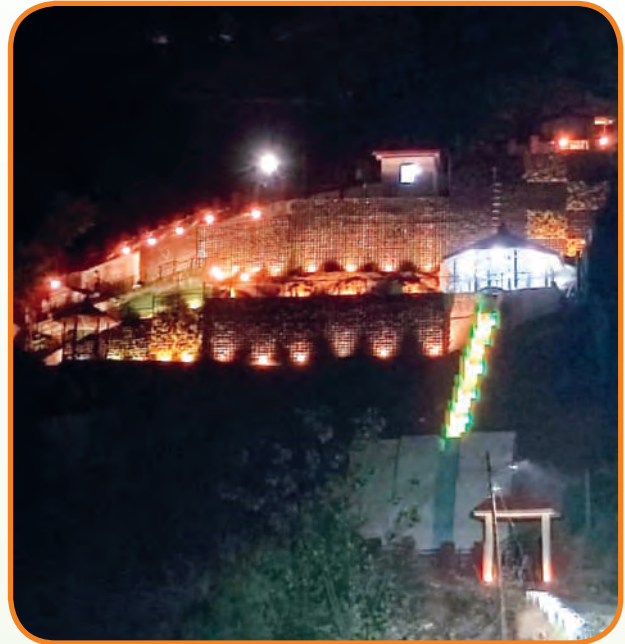


Development of bio-diversity park at Shanan, Shimla

In vicinity to the company's Corporate Headquarters at Shanan in Shimla, a bio-diversity park is being constructed. The park will offer facilities of playing game area for the local children, open air gym and a model of 1.3 Kw hydroelectric power station. For development of this park, a tripartite agreement has been entered between SJVN Limited, M/s Magnus Infra tech Pvt Ltd., and SJVN Foundation on 29th December 2021 for development of this bio-diversity Park. The total cost for construction of this bio-diversity park is estimated at ₹2,94,43,699/- and so far, an amount of ₹1,02,98,271/- has been released under CSR Budget FY 2021-22. The project is nearing completion.

The Bio-diversity Park will offer facilities like:

- Capital in Children park
- 1.3 Kw Hydro Power Plant,
- Open air Gym etc



Women and Child welfare Scheme

SJVN started "Women and Child Development scheme" in 2012-13 under which the Below Poverty Line (BPL) women residing in Project Areas of SJVN are eligible for a financial benefit of ₹10,000/- in two installments of ₹5,000/- each during ante-natal and post-natal period to enable healthy nourishment to the newborn child.

Besides the direct financial benefit, a gift pack worth ₹1000/- consisting of nutritional food items, soaps and other hygiene related items needed for the care of the newborn are also given to these BPL women.

In FY 2021-22, a total of 43 women were benefitted from this scheme and a total of 910 women have been benefitted till date.

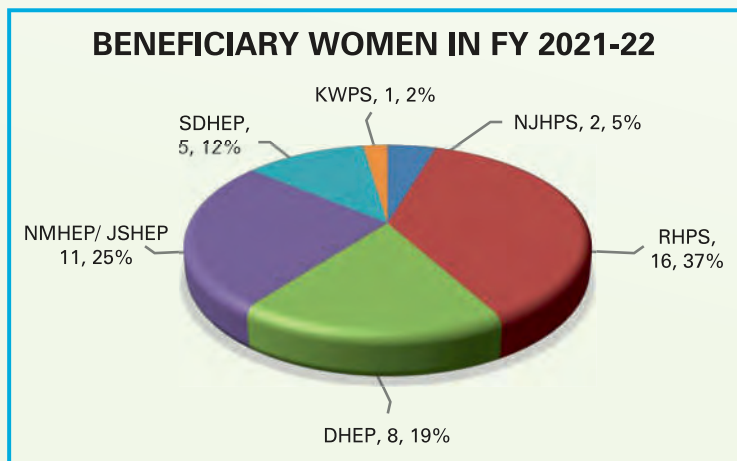

Support to Special Olympics Bharat (SOB) for Medical Screening Camps

Executive Director, Special Olympic Bharat requested for providing support of ₹1.50 Cr. for Medically screening camps of specially abled sportspersons under Azadi Ka Amrut Mahotsav. The camps will medically screen the Persons with Intellectual and Developmental Disability (PWIDD) to enable them to return to sports activities and encourage them to keep fit by demonstrating the Special Olympics Fit 5 program. The screening will cover 75000 special athletes across 75 cities in India and the program is slated for 7th April, 2022 i.e. on World Health Day. The total cost of the project was ₹15.6 Crore out of which SJVN has provided financial assistance of ₹1.50 Cr to empower the Intellectual Disable (ID) using sports, health, education and leadership program. The camps will also cover the training of Medical Professionals, Special Smiles (Dentistry) and Health Promotion of (Preventive and Nutrition) of Special Athletes.

Other key activities under Health

In addition to above the various activities conducted under health initiatives are summarized as below:

- i. 01 Ambulance each for Civil Hospital Nirmand, H.P and Project Hospital Bayal H.P with financial implication of ₹13.35 Lakhs were purchased and handed over to the concerned authorities.
- ii. X-Ray machines with financial implication of ₹3.95 lakhs purchased for Civil hospital Nirmand H.P
- iii. Medical Equipments provided to MGMS Complex Khaneri, H.P in which expenditure of ₹9.60 Lakhs incurred
- iv. SJVN has opened X-Ray facility in Project Hospital, Bayal, H.P through HelpAge India to extend better hygienic and low-cost services to the residents of project affected Panchayats. Total 42 patients consisting of 24 male and 18 female benefitted from the facility till date.
- v. Financial Assistance of ₹4.5 Lakhs and ₹12.16 lakh was provided to Regional Hospital Reckong Peo, H.P for purchase of Auto Haematology Analyzer Machine for blood test and APPAYag Laser Machine for eye test respectively.
- vi. Financial Assistance of ₹9.93 Lakh was also provided to Chief Medical Officer, District Kinnaur for purchase of Haematology Analyzer Machine for CHC Bhaba Nagar and PooH, H.P.
- vii. Specialized Medical health Camps was organized by KWPS at Village Kombhalne and Khirvire, Maharashtra with, General Physician and Research, Sai Kripa Clinic and Hospital, Sinnar and team of 10 specialized Doctors.

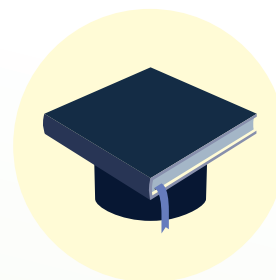

EDUCATION AND SKILL DEVELOPMENT

Education plays a vital role in the growth of society as well as nation and helps to improve quality of life with full utilization of skill for socio-economic development. However, unfortunately the availability of good quality and affordable education is very limited in remote and far-flung areas of the country. SJVN has therefore been continuously implementing a number of education and skill development programmes in the project areas. May it be in the field of providing building infrastructure or educational aids or offering scholarships to meritorious students for enhancing the skill set of youths, SJVN has been doing a lot to improve the lives of locals. The various schemes being run by SJVN in the sphere of Education and Skill development enumerated below:

Sponsoring youths in Govt. ITIs:

SJVN Foundation has long been sponsoring local youth to enhance their technical skills to increase their employability. In this direction SJVN provides monthly stipend of Rs 2000 apart from sponsoring the course fee to the local youth pursuing vocation training at the various Industrial Training Institutes (ITIs) in Himachal Pradesh, Bihar and UK in FY 2021-22. Four projects namely Luhri Hydro Electric Project, Sunni Dam Hydro Electric Project, Dhaulasidh Hydro Electric Project and Jangi Thopan Hydro Electric Project in the H.P have been allocated 80 seats under various disciplines of training in the ITIs.

The scheme had been suspended during FY 2020-21 due to unfavorable circumstances raised by COVID-19 pandemic while the course fee of students as well as the stipend of ₹2000 per month was continued for the enrolled students of the previous year. The scheme was resumed in the FY 2021-22, wherein 56 students were nominated by SJVN projects in various trades such as electrician, welder, fitter, vehicle mechanic, surveyor etc as under:

So far 843 number of candidates including above have been sponsored in government run ITIs in the state of H.P. by SJVN.

In addition, SJVN has nominated 25 local youth for 02 years ITI programme in Govt. ITI Buxar, Bihar in various trades such as ICTSM (05 No.), Electronic Mechanic (08 No.), Fitter (04 No.) and Electrician (08 No.) with a financial implication of ₹6.68 Lakhs. Also, DHEP Tharali, UK has nominated 13 No students in various Govt. ITI's for FY 2021-22 with financial implication of ₹0.78 Lakhs.





Deen Dayal Upadhyay SJVN Krishi Kaushal Yojana

To support the mission of Government of India to double the income of farmers by 2022 SJVN has taken up this unique initiative. Under this initiative SJVN has collaborated with Dr. Y.S. Parmar University of Horticulture and Floriculture, Nauni and CSK Agriculture University Palampur for imparting skill training to farmers in the area of new agricultural technology, new and scientific methods of cultivation. The farmers attending these short terms training programs are not only provided free travel, lodging and boarding facilities at the universities, but are also compensated for any loss of income by the way of payment of incentives

Further, to provide training to farmers who are unable to undergo residential training, SJVN provides training at their farms through local specialised experts/agencies. Due to Covid-19 the program was however deferred during the FY 20-21.

For the FY 2021-22, MoU has been executed with CSK University Palampur on 26.10.2021 for imparting skill training to 1000 farmers through 40 camps. Also, sanction letter issued to Nauni University on 17.01.22 for organizing 06 nos of one day farmer camp at Project location in H.P training approx. 1500 farmers. The details of training programs completed in FY 2021-22 are as under:

SJVN Merit Reward scheme for students and sportspersons of Kinnaur and Spiti

SJVN Foundation has introduced "SJVN Merit Reward Scheme for students and sportspersons of District Kinnaur and Spiti Sub Division H.P in the FY 2020-21. Under this scheme, the following support has been provided:

A. One-time reward to topper students and sportspersons

One-time reward to topper students of class 8th, 10th and 12th, Topper NIT / Medical college students, Sportspersons (State level medalists, National / International level participants / medalists) of Kinnaur and Spiti Sub division have been given. The amount of reward varies from ₹5000/- to ₹25,000/- under different categories. During the FY 2020 21, a total of 218 students/sports persons were rewarded under this scheme at a total expenditure of ₹18,92,200/-. And in the FY 2021-22, one time reward was given to 204 students and total financial implication of ₹14,73,000/-.

B. Assistance for Children's Science Congress (CSC)

SJVN has supported the Children's Science Congress (CSC) program being run by Elementary Education Department of Distt. Kinnaur and Spiti under "SJVN Reward Scheme for students and sportspersons of District Kinnaur and Spiti". The objective of CSC is to promote creativity and innovativeness among children to resolve societal problems being experienced locally using methods of science.

Under the scheme, one time running trophies were provided to the Nodal agencies of Children's Science Congress at a cost of ₹2,05,320/- for organizing the programs in District Kinnaur and Spiti Sub Division. Dy Director Elementary Education, District Kinnaur and Additional Deputy Commissioner, Spiti are the nodal agencies for organizing these programs. Besides the above an amount of ₹91,000/- was also provided to the Nodal agency of Children Science Congress of Kinnaur and Spiti for organizing the Children Science Congress-2020. Also, In FY 2021-22, an amount of ₹72000/- was provided to Deputy Director Elementary Education the Nodal agency of Children Science Congress of Kinnaur organizing the Children Science Congress-2021.





Skill Development Programs for Local Youth

For organizing short terms skill development programs for the local youth, a Tripartite MoU has been entered into between SJVN Foundation, National Skill Development Corporation (NSDC) and National Skill Development Fund (NSDF). The MoU is for training 2200 youth during FY 2019-20 through NSDC at a total financial implication of ₹6,06,60,434/-.

Earlier the target of training was for 2200 youth and accordingly the 1st installment of ₹1,81, 98,130/- i.e. 30% of the sanctioned amount of

₹6,06,60,434/- was released to NSDC on 13.02.2020. However, due to pandemic COVID-19, the target had to be revised to 840 candidates during FY 2020-21. Further on the request of NSDC an extension has been given up to June, 2022 for organizing the skill development programs. The status of trainings organized in FY 2021-22 (as intimated by NSDC) is as under:

The Institute Management Committees (IMCs) in respect of the 6 ITIs were notified by the Government of Himachal Pradesh. 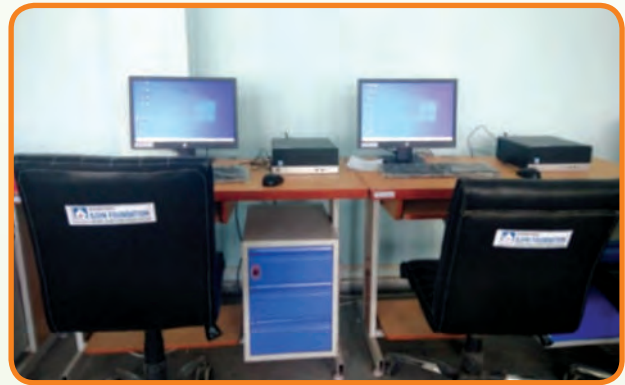

Strengthening and augmentation of Govt. ITI, Berthin, and ITI, Bangana

As per the Government of India's instructions SJVN has provided funds of ₹1.00 Cr. each to the ITI, Berthin, district Bilaspur, (HP) and ITI, Bangana district- Una (HP) during the year 2009 to 2012. The works have been completed and display board has been installed in both the ITIs. The progress work in both the ITIs is being monitored by duly constituted IMC headed by HOP Dhaulasidh HEP.

SJVN Silver Jubilee Merit Scholarship Scheme

To commemorate the Silver Jubilee celebrations, SJVN Foundation has introduced the Silver Jubilee Merit Scholarship Scheme in the FY 2012-13 for motivating students to pursue higher education in the streams of their choice. The scheme is open to all meritorious students who score at least 60 percent marks or equivalent grade in 12th class under State Education Board, CBSE or ICSE in the States of Himachal Pradesh, Uttarakhand, Bihar, Maharashtra and Gujarat. Reservation is given to students from BPL families and PWD candidates.

The scheme since its inception is being operated through HIMCON. Due to covid-19, the scheme was put on hold for the FY 2020-21 for new students, however during the FY 2021-22 applications for both FY 2020-21 and FY 2021-22 were invited, the details of which is as follows:

Construction of Hostel block in HP National Law University

As a measure to promote women empowerment and girl education, SJVN Foundation has sanctioned financial support of ₹10.80 Crore to Himachal Pradesh Law University (HPNLU), Shimla for construction of a girls' hostel block. Accordingly, a MOU was signed with Registrar HPNLU to this effect. The first installment of 50% amount i.e. ₹5.40 Crore had been released on 24.03.2020 while utilization certificate of ₹2.00 Crore has been received. The work is under progress.



Construction of Hostel for Tribal Children in Shimla

Secretary, Himgiri Kalyan Ashram had requested SJVN for financial support for construction of the first floor of boy's hostel for tribal children with intake capacity of 50 students at Mehli, Distt. Shimla. The agency works for the development of tribal persons of all the age groups by providing them facilities of free Hostel, coaching, sports, women development, skill development, yoga, etc.

Accordingly, SJVN Foundation, agreed to extend financial support of an amount of ₹50.00 lakh for construction of 1st Floor of the building. The total amount of ₹50.00 lakh has been released to the agency in two instalments and the work has been completed.





Installation of Grid connected Solar Power Plant in GHSS Munderi, Kannur.

To promote infrastructure development and modern facilities in order to increase the enrolment and improvement of modern amenities in Govt. Schools at Munderi, district Kannur, Kerala, SJVN Foundation has executed MOU on 16.11.2019 with District Panchayat, Kannur for installation of a Grid connected Solar Power Plant in the school at a financial implication of ₹66.85 Lakhs. So far ₹60.16 Lakhs have been released to District Panchayat Kannur. Pending commissioning of the plant, the installation, cabling work has been completed and the transformer has also been erected at site. The balance works are in progress.



Handloom weaving training to weavers and artisans of H.P

To promote 50 start-ups by 2022 and meet the target given by the Central Public Sector Enterprises, (CPSE Conclave), SJVN Foundation has undertaken the work of imparting skill development trainings in handloom weaving as per following details:

(a) Through Swablamban and Kinnaur Heritage Foundation:

One unit of Handloom weaving centre comprises of 10 participants and seven such unit organised, 70 participants have been trained so far and each participant has been provided with a loom worth ₹15,000 for pursuing self-employability. During the period of training these participants were also provided monthly stipend of ₹1,000 per participant.



(b) Through HP State Handicraft and Handloom Corporation Ltd, Shimla:

A MOU was entered into between SJVN Foundation and H.P. State Handicraft and Handloom Corporation Ltd. (HPSHandHCL) on 04.03.2020 for organizing 20 training programmes covering 10 candidates each at a financial implication of ₹1.12 Crores and accordingly 1st instalment of ₹33.60 lakhs (i.e. 30% of ₹112.00 lakhs) was released to HPSHandHCL on 20.03.2020.

However, due to the outbreak of COVID-19, SJVN Foundation had decided to limit the trainings to only 6 centers. The amount of expenses therefore too was limited to 30%, as already released in 1st installment. Out of these 6 centers, training in 4 centers has been completed, one is under progress and one center will be started soon. The details are as under:



1. NJHPS : GP Jeori, Training completed on 16.08.21
2. RHPS : GP Averi, Training completed on 01.09.21
3. LHEP : GP Dehra, Training completed on 03.09.21

All the participants were provided a monthly stipend of ₹1,500 during their training period while a loom worth ₹12,000 was also provided to each one of them for pursuing self-employability in handloom weaving in future.

Awareness on Citizen's Fundamental Duties

The Department of Justice had directed all CPSUs to organize events and activities to generate awareness on Citizen's Fundamental duties. It was desired that activities such as speech/debate contests, distribution of pamphlets, seminars and rallies be organized to create awareness among general public about Indian Constitution and Citizen Fundamental Duties during the year 2020-21. Accordingly, SJVN prepared a calendar of different awareness activities and has implemented them across all project locations. Major events like Constitution Day, Republic Day were organized at all the projects. Apart from this, local communities were educated about the Indian constitution and its different parts through pamphlets, street plays, quiz competitions in schools etc. More than 4000 people were benefitted through this campaign.



An awareness programme on legal rights and duties of citizens was organized through district court, Buxar. An awareness programme during the Iconic Week under Azadi Ka Amrit Mahotsava was also organized through the office of Dy. Labour Commissioner (Central), Patna in March 2022 for 1500 labours.

Construction of Sainik Training Academy at Barchwar, H.P.

SJVN sanctioned financial support for construction of a hostel block of Sainik Training Academy at Barchwar in Tehsil Sarkaghat in District Mandi. The Sainik Training Academy is proposed to be set up at Barchwar, Tehsil Sarkaghat, Distt. Mandi, H.P. at an estimated cost of ₹310.91 lakhs which will help and encourage youth to join Defense and Central Armed Police forces by acquiring intellect, physical and character qualities of the standard required thereto. The financial support of ₹20.00 Lakh (as 1st installment) has been released and the work is in progress

Construction of temporary classrooms at Bagsaid, H.P.

SJVN Foundation has provided financial support of ₹35,62,320/- for construction of temporary classrooms of prefabricated structure in Government Senior Secondary School, Bagsaid Tehsil-Thung, Distt. Shimla. Aim of the project was to provide facility of temporary classrooms of prefabricated structure for the students so that their studies don't get affected. The construction work was carried out by Ropeways and Rapid Transport System Development Corporation of H.P. The agency constructed the classrooms with prefabricated structures immediately by virtue of which the educational activity in the school has been restored.





Renovation of Govt. High School Vikas Nagar, Shimla

To facilitate digital literacy to approx. 100 students of Government High School, Vikas Nagar SJVN Foundation sanctioned to the following:

1. 02 computers with UPS and 01 printers since the school didn't have any ICT lab.
2. Repair works in the school toilets, playground, main gate, boundary wall, flooring, attic work etc.

Based on committee report, SJVN Foundation agreed to extend the financial support of ₹9,93,107/- lakh and so far, ₹9,55,518/- of the fund has been released in three installments. Further the work has been completed and last installment will be released after committee visit.



“VOICE” (Vivekanand organization of information, communication and empowerment) Centre

An NGO Prayas has approached SJVN seeking financial support for setting up of a project named VOICE (Vivekanand Organisation for Information, Communication and Empowerment) centers in District Hamirpur, Himachal Pradesh. The financial support sought was of ₹1,36,10,000/- and this amount included construction of building, furniture and operational expenditure annually. The Prayas aimed to provide basic computer skills to local people to make them computer literate.

SJVN has extended financial assistance of ₹19,10,690/- to Paryas Society for running the computer training program under the banner VOICE. So far an amount of ₹15,53,675/- has been released to the NGO.



Skill Development training to local youth and young women of slum areas

Often the youth of slum area are very talented but neglected due to lack of proper guidance and resources to showcase their talent. Hence with a view to enhance the skill ability of local youth and young women of slum so as to increase their employability, SJVN foundation has been providing financial support to Youth Resource Centre (YRC) run by AAROHAN, New Delhi for providing skill development training in employable trades to them. The details of trainings are as under:

Construction of Kanya Chhatrawas (Girl's hostel)

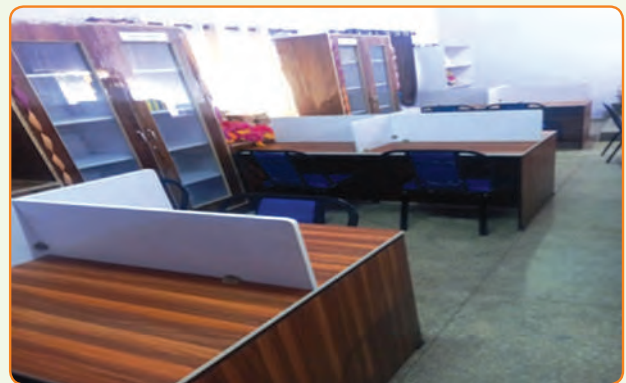
SJVN extended financial support of ₹1.85 Crore in 05 installments to Sh. Dhudhiya Baba Sanyas Ashram Rudrapur, Uttarakhand (being run and managed under the supervision of Sewa Prakalp Sansthan) for construction of hostel building for 180 orphan girls whose parents are inflicted with leprosy. The construction of the building has been completed and last fifth installment of ₹36.55 Lakh released on 22.05.2020.





Other activities under Education and Skill Development

- To boost the morale of the student and for cognitive as well as physical development of the students SJVN Foundation through NMHEP provided financial assistance of ₹1.00 Lakh to Parvitya Jan Sewa Sangathan for organizing essay writing competitions, group discussion and poetry competitions.
- SJVN provided better infrastructure to various schools of project affected areas with a view to promote education and skill development amongst the students. The details are as under.
 - » Provided 50 Two Seater Desk to SJVN DAV Public Senior Secondary School Duttanagar and 10 for Koshish-ek-Asha (NGO) at Rampur, Tehsil Rampur, Distt. Shimla. (H.P). SJVN spent ₹3.90 Lakh during FY 2021-22.
 - » Lab equipment's, furniture for Library and Musical instruments were provided to Govt. Senior Secondary School Duttanagar with an expenditure of Rs 4.40 Lakh during FY 2021-22.
 - » Laboratory articles / instruments and furniture were provided to Rani Rattan Kumari Memorial Govt. Senior Secondary School Nogli, Tehsil Rampur, Distt. Shimla H.P. SJVN with expenditure of ₹1.35 Lakh during FY 2021-22.
 - » Financial assistance of ₹5.00 Lakh was provided to local Govt. School in Sikraul Panchayat for procuring furniture and others items.
 - » Sports equipment and class room furniture was provided to SJVN DAV Public School Duttanagar. SJVN for which expenditure of ₹10.52 Lakh incurred during FY-2021-22.

SUSTAINABLE DEVELOPMENT

Restoration of water bodies

In order to make access to water adequate and equitable, we must shift our focus from water sources to water resources or say water bodies. Apart from available rainwater and reuse of treated wastewater, water bodies (lakes, ponds) especially in urban areas have enormous value in terms of resource provision (for drinking or irrigation). In hilly areas due to the mountainous terrain, ground water recharging does not happen and all rain water goes waste. To tackle this issue, SJVN over the years has supported villagers in the vicinity of its project areas in building tanks and rehabilitation of existing water bodies like springs, ponds etc. During the FY 2020-21 and FY 2021-22, twelve water bodies were undertaken for restoration as detailed hereunder:

Construction of Multipurpose Dam for water conservation at Nahan, H.P.

Water conservation is important because fresh and clean water is a limited and costly resource. Equitable distribution and supply of water is therefore considered to be a wise method. Jal Shakti Vibhag, Nahan, Distt. Sirmour H.P had requested for financial support for construction of multipurpose medium height dams at 07 locations in Nahan constituency for rain water harvesting and water conservation which is also helpful for recharging the depleting ground water level due to over exploitation by the industries in the area. The local house dwellers were facing water supply problem hence SJVN considered undertaking the activity of construction of dams at village Gount and sanctioned financial assistance of ₹57.39 lakhs for construction of dam on Gount Khad. The project is now operational and is providing water and irrigation facility to more than 15 villages of nearby areas



Installation of LED based Solar Street lights and Dustbins in Himachal Pradesh

a. Supply and Installation of 5,750 Solar Street Lights in H.P.

Solar street lights and dustbins in 23 constituencies of Shimla and Mandi districts of Himachal Pradesh were provided by SJVN Foundation with a view to promote clean and green environment. The project was envisioned to be executed out of CSR funds of the power sector PSUs as directed by the MoP. A total 23,000 dustbins have already been installed in all the 23 Assembly constituencies, covered under Shimla and Mandi Parliamentary Constituencies of H.P.



However, with respect to supply, installation and commissioning of 12W LED based Solar Street lights, out of a total 5750 no. solar lights were to be installed in 23 Assembly Constituencies of H.P. So far 4750 solar street lights have been installed in 19 constituencies and for the remaining constituencies, the work of physical site verification is in the process. A payment of ₹7,71,46,792/- has been released in favour of EESL. The supply and installation of the balance lights is under process.





b. Supply, Installation and Commissioning of 700 LED based Solar Street Lights

To promote the use of renewable energy, SJVN has long been installing solar street lights in and around its project areas. In the ongoing process SJVN envisaged installation of additional 700 Solar Lights (12W LED) in and around the project areas in Himachal Pradesh and its Headquarters at Shimla. For the installation, a MOU was signed on 28.10.21 with EESL at a financial implication of ₹1,12,70,000/- and accordingly first installment of ₹52,43,571/- (40% of the project cost) was released to the EESL on 21.12.21. The supply and installation of the lights is under process.

c. Other initiatives for installation of Solar lights in SJVN Project Areas:

With a view to promote clean and green environment on the request of local village panchayats, local legislators etc, SJVN has provided financial assistance for supply and installation of 12 W solar lights in and around its project areas. The installation of these solar lights will benefit local public as well as raise the overall well-being of the villages like easy movement during evening hours, reduce snake bite incidents, improved sense of security among women and children etc. The details of lights installed are as under:

Implementation of horticulture-based livelihood project in four Gram Panchayats of Distt. Kinnaur, HP under NJHPS project affected area

Chairman, Hill Agriculture and Rural Development Promotion Society (HARP), Shimla had shared a proposal for providing financial support of ₹585.80 Lakh (out of ₹1396.9 lakh) on sharing basis with NABARD for implementation of a Horticulture based livelihood project (integrated Tribal Development Projects) in the four Gram Panchayats of Distt. Kinnaur, viz. Bari, Ponda, Sungra and Taranda situated on the left banks of River Satluj, covered under the NJHPS affected areas.

The basic four activities carried out in the aforesaid project are as under:

- Orchard establishment on farmers' field,
- Water Resource Development,
- Livelihood activities for landless families, and
- Training and capacity building.

A tripartite MOU was executed by SJVN Foundation, NABARD and HARP on 07.07.2020. Head of the Project, NJHPS Jhakri, has been nominated as Nodal Officer for this Integrated Tribal Development Program. The execution of the project is under process. Out of the sanctioned amount of ₹222.33 lakh an amount of ₹164.42 Lakh has been released to the agency in three installments. The program implementation is under progress and is being closely monitored by NJHPS, which is nodal agency for execution of the project.



Awareness on Energy Conservation- State Level School Painting Competition

The State Level Painting Competition initiated by BEE, Ministry of Power is organized every year under National Awareness Campaign in HP by SJVN. In FY 2021-22 the state level painting competition was conducted in which the school students of H.P participated in two groups Group A for junior classes and Group B for senior classes. A total of 26 prizes were distributed amongst the students. Over 10 Lakh students have participated in this awareness campaign since 2011.





Survey of toilets constructed under Swachh Vidyalaya Abhiyan through NABARD Consultancy Services (NABCONS)

One of the main objectives of Swachh Vidyalaya Abhiyan is to reduce the school drop-out rate and to create a sense of self hygiene cleanliness among adolescent girls. SJVN has constructed 2421 toilets in Himachal Pradesh, Uttarakhand, Bihar and Arunachal Pradesh under Swachha Vidyalaya Abhiyan. A lump sum annual maintenance amounts up to ₹5000/- per toilet is also being provided to the schools for general maintenance like repair, change of cistern, seat, tap, wash basin, doors, water tanks, other sanitary fitting, white washing, painting etc. Reimbursement of a total expenditure of ₹80,000/- has been made to the schools for the maintenance of toilets during FY2020-21.

Further as per the directions of Ministry of Power, SJVN conducted third party survey of all the 2421 toilets constructed by SJVN under Swachh Vidyalaya Abhiyaan. The survey was conducted through NABCONS (a subsidiary of NABARD) at a financial implication of ₹32.00 lakh plus GST. As per the directions of MOP all the dysfunctional toilets are required to be made functional and handed over to the concerned state education departments. NABCONS submitted its draft survey report on 29.06.2021 and as per the reports 80 no. of the toilets were left out (14 no. toilets not found during survey + 66 no. toilets in the schools closed at the time of survey). Hence, the left-out toilets were resurveyed for which resurvey was conducted through NABCONS at an additional cost of ₹91,200+GST, thus revising the total financial implication to ₹32,91,00/- plus GST. Thereafter, NABCON vide its letter dated 01.02.2022 has submitted its final report which depicts the following findings:

As per the finding of the report, the repair work in all the 253 dysfunctional toilets to make them functional has been started by the respective projects and 133 toilets has been handed over to respective department of GOHP. The work is under progress in remaining toilets. Overall, out of total 2421 toilets constructed by SJVN under SVA, 2246 toilets have been handed over to concerned departments of respective states.

Maintenance of toilets constructed under Swachh Vidyalaya Abhiyan (SVA)

SJVN has constructed 2421 toilets under SVA in the states of H.P, UK, Bihar and Arunachal Pradesh. Further to maintain the same it was decided to keep a lump sum maximum amount of ₹ 5000/- per toilet per FY which will be released by the respective project to the schools on receipt of verified vouchers/bills from principal of the respective school. The Project-wise expenditure made on the maintenance of the toilets during FY 2021-22, is as under:

Installation of portable toilets at Bilaspur H.P.

The Baba Balaknath Temple, Bilaspur (HP) management had requested for installation of two portable toilets in the temple as pilgrims were facing a lot of problem in the absence of a public toilet. Hence, as a sanitation measure, SJVN purchased and installed two portable toilets at the temple premises through DSHEP, Hamirpur H.P. The toilets are in use and being maintained by the temple committee.

Construction of Toilets in Govt. Schools and Construction of Community Toilets:

The schools and villages fall under SJVN project area are situated in remote area with a minimum infrastructure facility, lack of sanitary toilets which creates lot of problem to locals/students and they suffer from various communicable diseases.

This step helped them to save them from various diseases. Around 5000-6000 locals are getting benefit by this. SJVN has spent ₹ 68.40 Lakh during FY-2021-22 for various works as under.

- Construction of Toilet in Govt. Senior Secondary School Randal, Gram Panchayat Brow, Tehsil Nirmand, Distt. Kullu (H.P).
- Construction of Community Toilet near Sarai Bhawan Dhamshan Devi Temple at village Gaonbeel, Gram Panchayat Tunan, Tehsil Nirmand, Distt. Kullu.
- Construction / completion of toilet in the Ambika Mata Temple at Nirmand, Gram Panchayat Nirmand, Tehsil Nirmand, Distt. Kullu (H.P).
- Construction of Community toilet Under Swachh Bharat Mission at Mela Ground near Bus Stand in village Koyal, Gram Panchayat Gadej, Tehsil Nirmand, Distt. Kullu (H.P).
- Construction of toilet Under Swachh Bharat Mission at Tunan (Near Busstand), Gram Panchayat Tunan, Tehsil Nirmand, Distt. Kullu (H.P).
- Financial assistance of ₹38.20 lakh provided to District Administration for the construction of toilets in the campus of District Collectorate, Uttarkashi which is located on Char Dhaam Yatra Marg
- Community toilet /Bathroom was constructed Near Shiv Temple, in village Naitwar with financial implication of ₹3.16 Lakh.





Purchase of Swachhta Vahan for Lahaul and Spiti:

SJVN Foundation provided financial support of ₹ 9,25,838/- to Deputy Commissioner, Lahaul and Spiti for the purchase of a Swachhta Vahan. The Swachhta Vahan was inaugurated by Hon'ble Minister Dr. Ram Lal Markanda during the Opening Ceremony of Snow Festival at Keylong on 25th January 2021. The Swachhta Vahan shall be utilized by the district administration for spreading awareness and cleanliness activities in Lahaul and Spiti district.



Observance of Swachhta Pakhwada:

Inspired by the Hon'ble Prime Minister's call for Swachh Bharat, SJVN took various initiatives under Swachh Bharat Abhiyan. SJVN observed Swachhta Pakhwada at all its offices and projects located in Himachal Pradesh, Uttarakhand, Bihar, Arunachal Pradesh and Maharashtra with host of Swachh Bharat activities having a long-term impact in the society. In this regard, keeping in mind the guidelines of Ministry of Home Affairs on Covid -19, an Action Plan was prepared and circulated among all projects of SJVN for its implementation.

A brief detail of different swachhta activities undertaken during the Pakhwada is as under:

- **Swachhta Pledge:** Swachhta Pledge was administered to all employees of SJVN across all offices and projects located in the state of Himachal Pradesh, Uttarakhand, Bihar, Arunachal Pradesh, Maharashtra, Gujarat and Delhi.





- **Awareness on Swachhta Pakhwada**

An awareness drive to spread the message of Swachhta Pakhwada among the company employees and members of their families was undertaken through social media and the company's website.

Social Awareness Message on "Swachhta" was also played through FM Radio: - "Big FM" during the period of Swachhta Pakhwada.



- **Special Drive during Pakhwada Period**

A special drive was conducted to distribute hand wash liquids, gloves, dusters etc. to workers deployed for sweeping and cleanliness in the office as well as in Power House Complex at Rampur Hydro Power Station, Prantiya Rakshak Dal (PRD) and local vendors of Naitwar Mori at Uttarkashi, Uttarakhand.

- **Installation of dustbins**

A number of dustbins were installed for propagating the message of segregation of wet and dry waste at project offices of SJVN during the Pakhwada period.



- **Swachhta Awareness through Mobile Medical Units**

A Swachhta Awareness Campaign was conducted by Buxar Thermal Power Plant in the Project Affected Areas of Bihar. Printed leaflets were also distributed among the local public to apprise them about maintaining personal hygiene and social distancing to fight against the COVID-19 Pandemic.





- **Maintaining cleanliness at workplace**

Cleanliness drives were conducted at work places where masks and sanitizers were also provided to employee of SJVN as a preventive measure from COVID-19.

INFRASTRUCTURAL DEVELOPMENT AND COMMUNITY ASSET CREATION

Infrastructure is important for faster economic growth and alleviation of poverty in the country. Infrastructural services are essential for better inter-societal and institutional connectivity and to unite with the mainstream of the nation. SJVN Foundation, under its CSR vertical “Infrastructural and community development” for infra development has been undertaking activities like construction of school buildings, hospitals, roads, bridges, public toilets, bus stands, public parks, play grounds etc. The selection and execution of these activities is carried out with the participative involvement of village development area committees, school management committees, panchayats, community-based organizations etc. so as to bring transparency and to develop a sense of ownership amongst the users.

Construction of Community Assets:

As on 31st March 2022, the following assets have been constructed/ are being constructed in FY 2021-22 including the assets which have been started in FY 2020-21:

Installation of benches in various wards of MC Shimla

Municipal Corporation, Shimla, had been requesting for installation of benches in its various wards. SJVN Foundation consented and agreed to extend financial support of ₹24.30 Lakhs for installation of 243 benches in all the 34 wards of Shimla. The benches are being installed by the MC.





On further requests received from Ward counsellors, a consent was also given on 24.06.2022 for installation of 35 more benches in 04 wards of MC Shimla at a cost of ₹10,000/- per bench. Thus, the number of benches to be installed is now 278 at a revised project cost of ₹27.80 Lakhs.

Based on the LOAs for the installation of benches, ₹11,17,208/- has been released to MC Shimla and total 150 no. benches have already been installed in various wards of MC Shimla. The work of installation of balance benches is under progress.

Construction of Shops and Pavilion near Sujanpur Bus stand

The request for construction of shops and a pavilion near Sujanpur Bus stand at a total financial implication of ₹61.88 lakhs was received from the office of SDM Sujanpur.



The construction of pavilion at Chagan would facilitate the sitting arrangement for locals during the public functions/melas// sports events etc organized in the Chagan ground and the construction of shops under the pavilion would generate the sources of livelihood for the local public.

The construction work has been completed at a total financial implication of ₹72, 53,246/- through SDM, Sujanpur and SJVN has extended a total financial support of ₹66.88 Lakhs (₹ 5.00 Lakhs above the initially approved cost estimate) for the project.

Renovation/Construction of shed and retaining wall in Shree Kamnapurni Gaushala, Samiti, Tutu, Shimla (HP).

Shree Kamnapurni Gaushala, Tutu, Shimla (HP) vide their letters dated 24.03.2021 and 27.04.2021 had requested SJVN to provide financial support of ₹30.18 lakh for renovation/construction of a shed and construction of retaining wall in Shree Kamnapurni Gaushala Samiti at Tutu, Shimla. SJVN Foundation has agreed for providing the amount as proposed on the basis of committee report. Further, the first installment of ₹6,03,600/- has been released to Kamnapurni Gaushala Tutu to start the work. The work is in progress.

Construction of retaining wall in IVY International School, Shimla

The Principal IVY International School, Shimla has requested to price financial support for construction of retaining wall in the playground of IVY International School, Shimla with a view to create safe environment for school children and local children for sports activities in the school premises.

SJVN foundation considered the same and the based on the committee report an amount of ₹22.90 Lakhs was sanctioned for the construction of retaining wall in the school. Accordingly, an amount of ₹11.45 Lakh has been released on 15.02.2022 as first installment. The work is completed and the final installment will be released subject to the final committee visit.

Gram Panchayat Pardhan, Choru had requested for financial assistance for construction of a Community Hall at village Choru. After receipt of detailed estimates from the Panchayat a financial assistance of ₹5.28 lakh was extended for construction of the Community Hall at Village Choru. The work has now been completed with participative involvement of Village Development Area Committee (VDAC). The VDAC has members from the Project and Panchyati Raj Institutions (PRIs). The community hall is benefiting the villagers for celebration of occasions and traditions, public meetings, social support, public information, and other purposes.





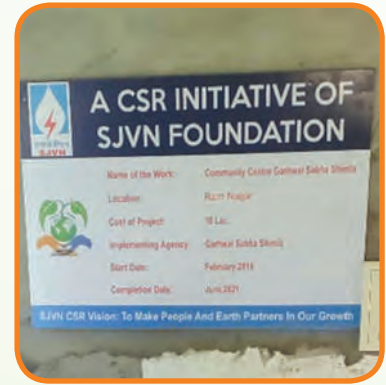
Construction of 06 community halls in Kangra (HP).

A request had been raised by Hon'ble speaker of Himachal Pradesh for extending financial support for construction of 06 community halls at a cost of ₹72.00 lakh (@12 lakh per community hall) in 06 Panchayats of Kangra constituency (HP). SJVN Foundation has agreed to extend financial ₹36.00 lakh for the construction of 03 community halls, through BDO Sullah. An amount of ₹7.20 Lakh (20% of ₹36.00 Lakh) has been released as first installment to BDO Sullah for construction of three community halls. The work is in progress.

Construction of community hall in Ram Nagar, Shimla

Garhwal Sabha, Ram Nagar, Shimla had requested for financial support of ₹10.00 Lakh for construction of a community hall at Ram Nagar, Shimla. The proposal was approved in the 24th Foundation meeting. Accordingly, a financial support of ₹10.00 lakhs was released to the Sabha in three installments. The work was completed and utilization certificate of funds was submitted by Garhwal Sabha.

Further Garhwal Sabha vide letter dated 03.08.2021 had requested to provide additional funds of ₹15.00 Lakhs to complete balance work of 1st floor and construction of 2nd floor. SJVN Foundation has agreed to extend the additional financial support of ₹5.00 lakh for carrying out the finishing work of the 2nd floor. First installment of ₹2.00 lakh was released to the Garhwal Sabha on 17.12.2021. The work is in progress.



Construction of assets in Project affected area of Rampur HPS:

The Project affected Panchayats of RHPS are situated in remote and hilly area. SJVN has created 4 No. community Centers/Mahila Mandal Bhawans/ Repair of School Building in Panchayat Bahwa, Kharga, Gadej for facilitating Panchayats to organize public meetings, help poor people to use these Center for marriage of their children with a minimal charge and to generate employment, improvement in income of the locals. Around 2000-3000 persons are getting benefit per year. These activities also help to create goodwill gesture among locals towards SJVN LTD. SJVN had spent ₹12.84 Lakh during FY-2021-2022.

- Construction of Community Centre in the Temple Complex of Duttatreya Temple, Gram Panchayat Duttanagar, Tehsil Rampur, Distt. Shimla (H.P).
- Developing existing Rain Shelter into Stage at Village Bayal
- Printing, fabrication and installation of aesthetically designed display board for activities completed under CSR Deptt. of Rampur HPS, Bayal P.O. Koyal, Tehsil Nirmand Distt. Kullu.
- Repair of School building i.e. Painting and Distempering in DAV SJVN Senior Secondary School Building (Block A, BandC) at Duttanagar, Tehsil Rampur Bushahr, Distt. Shimla.

Construction of ambulance road at Gram Panchayat, Pujarli

A request was received from Gram Panchayat Pujarli for providing financial assistance of ₹ 10.00 Lakh against the total estimated cost of ₹ 18.00 Lakh for construction of 1.5 km ambulance road from main road to village Kawalag. On the basis of committee's recommended for construction of breast wall and retaining wall for the stability of road, SJVN Foundation agreed to extend the financial support of ₹ 10.00 Lakhs as requested. So far, a sum of ₹ 8.00 Lakhs has been released to Gram Panchayat Pujarli. The work is under progress.



Construction of Ambulance link road at Gram Panchayat Kot Shilaroo

Pradhan, Gram Panchayat Kot Shilaroo had requested for providing funds for construction of about one km long ambulance link road from Chalai to Government Senior Secondary School, Kot Shilaroo. Accordingly, a financial assistance of ₹5.15 Lakh was sanctioned to Gram Panchayat Kot Shilaroo. The first installment of ₹3,09,000 (60% of the sanctioned value of ₹5,15,000/-) was released in favour of Gram Panchayat, Shilaroo on 10.09.2020. It has been informed by the gram Panchayat Shilaroo that the construction work will be started after receipt of NOC from Forest deptt.



Metalling and tarring of road from Bayal to Koyal

On recommendations of 20th meeting of COD, for considering the work of metalling and tarring of 3.64 KM road from village Bayal (batching plant) to village Koyal, a financial support of ₹2,08,52,094/- under CSR was approved by the Board of Directors in its 255th meeting held on 11.08.2017. Accordingly, the work of the project was completed in FY 2021-22, the total amount of ₹2,08,52,094/- has been released in 03 instalments.



Financial support for School-cum-Home for special children at Dhalli, Shimla

The Committee of Directors in its 16th meeting recommended provision of a financial support of ₹827.99 Lakhs for construction of School-cum-home for visually challenged and speech and hearing-impaired children at Dhalli over a period of three years 2016-17, 2017-18 and 2018-19. The recommendation was approved by 249th BOD. Accordingly, a consent letter dated 06.12.2016 was issued to Social Justice and Women Empowerment Department, Govt. of HP offering a financial support of ₹827.99 Lakhs, and a MOU was hence executed on 21.03.2017.

The work is being executed through HP PWD and an amount of ₹5.18 crore has already been released to the agency. In the Joint site visit by S.J.V.N officials and representatives of the Directorate of OBC/SC, and HPPWD on 07.10.2021 it had been observed that 70% of the structural work has been completed and the remaining work will be completed by June, 2022.





Furnishing of ground floor of "Research and Rehabilitation centre", Chetna Bilaspur

With a view to rehabilitate differently abled persons, Chetna, an NGO had requested for financial assistance for construction/furnishing of ground floor of Research and Rehabilitation centre for differently abled and deprived sections of society at Village Vijaypur, Pargana, Gehrwin, Tehsil Jhanduta, Distt. Bilaspur (H.P). SJVN Foundation has provided financial support of ₹1.00 Cr. to Chetna to complete the ground floor work. Further, on request of Chetna for installation of lift in the building, ₹37,00,000/- has been released in two instalments. Hence, total support given to Chetna amounts to ₹1,37,00,000/- and the work has been completed.



Repair of link road of Gram Panchayat Chamiyana

Gram Panchayat, Chamiyana had requested SJVN for financial assistance of ₹4.00 lakh for repair of link road from lower Kalhali to upper Kalhali Gram in Panchayat Chamiyana, Shimla. SJVN vide its letter dated 16.06.2021 agreed to extend financial support of ₹4.00 Lakhs for the aforesaid work. Accordingly, the amount of ₹4.00 Lakhs has been released in 02 installments. The work is in progress.



Renovation of rain shelter in summer hill chowk, Shimla

Councilor, Summer Hill, Shimla requested SJVN for providing financial support for renovation of a rain shelter at Summer Hill Chowk, Shimla at an estimate of ₹8.09 Lakh. Based on the committee report a consent letter dated 23.02.2021 was sent to Executive Engineer, MC, Shimla for execution of the work. Accordingly, the first installment of ₹4,04,500/- (50% of the sanctioned amount) was released on 14.12.2021. The work is under progress.

Fencing of GSSS Bhattakufer, Shimla

A request was received from Principal GSSS, Bhattakufer for fencing of windows and corridor of the school premises with a view to provide safe environment to the students from monkeys and also safeguarding the property of school. The SJVN Foundation considered the request for providing ₹4,49,747/- for the fencing work of school. Till March 2022, an amount of ₹2,69,848/- has been released in 02 installments to the school and the work is under progress.





Sansad Adarsh Gram Yojana at Village Simas, H.P.

SJVN sanctioned financial support of ₹70.23 Lakh for developing village Simas, Tehsil Lad Bharol, Distt. Mandi as an Adarsh Village under 'Sansad Adarsh Gram Yojana'. The work consists of constructing a multipurpose hall, Mahila Mandal Bhawan, Channelization of Nallah, installation of high mast lights etc. So far funds of ₹28,09,465/- have been extended to BDO Chauntra. Utilization of ₹15,58,215/- along with the progress report, has been received from BDO Chauntra vide letter dated 04.09.2021. The work is in progress.

Construction of CSD canteen and Sainik Aramgah at Sandhole, Distt. Mandi

SJVN under its CSR initiatives sanctioned ₹1.00 Crore for the construction of CSD canteen and Sainik Aramgah at Sandhole, Distt. Mandi. The work is being executed through Jal Shakti Vibhag, Dharampur. The Sainik Aramgah and CSD canteen will benefit the army personnel and their families over the time. Till date an amount of ₹40 lakhs has been released in 02 instalments to Jal Shakti Vihag and the work is under progress.

PRESERVATION AND PROMOTION OF LOCAL CULTURE AND SPORTS

SJVN Foundation has always remained concerned for preservation of local culture and traditions by associating itself with their promotion and also funding renovation and restoration of temples in the vicinity of its projects. The company also extends financial support for the preservation and promotion of national and local festivals, cultures, and sports. Cultural heritage and natural history of a region has a very high value and is always unique and its preservation is a part of the developmental activities of a corporate. SJVN has therefore made it a part of its business. The company has taken steps to preserve and promote the culture and heritage by undertaking the following activities:

Development, renovation and reconstruction of Bhimakali Temple

Ma Bhimakali Temple in Sarahan, near SJVN's Nathpa Jhakri Power Station, is a historic temple popular not only amongst locals but tourists as well. The old temple needed renovations and SJVN instantly came forward to render the required assistance. Financial support of ₹1.00 crore was extended for repair and reconstruction of Bhimakali Temple by the company through its Nathpa Jhakri Power station. NJHPS has already submitted the UC of ₹80.00 Lakh as provided by Bhimakali Temple. Earlier the temple committee had informed that the works have been delayed on account of COVID-19 pandemic, however as per the latest status 85% of the work stands completed and the entire work is likely to be completed by 31.03.2022.



An amount of ₹31.70 lakh has accrued as interest on the funding of ₹1.00 Crore, out of which ₹5,35,910/- is proposed to be utilized in renovation of main gate and walls of the temple and the remaining amount of ₹26,34,812/- will be utilized for construction of a library and renovation of roof of old fort inside the temple. The work is in progress.





Construction of Community Hall and rain shelter at Shri Berang Nag Mandir, Sangla

SJVN Foundation has extended financial assistance of ₹75,35,400/- for Extension of Mandir complex, construction of a community hall and rain shelter in Devta Shri Berang Nag Temple at Sangla. So far, an amount of ₹52,74,780/- in two installments has been released to the temple Committee for execution of the work. Almost 70% of the construction work has been completed and the remaining works are in progress.



Construction of Mela Ground at Tattapani, Sunni (H.P)

SJVN Foundation has extended financial support of ₹1,05,71,756/- for the construction a Mela ground at Tattaani Sunni (HP) for the locals and pilgrims visiting historic Hot water springs near Sunni. As per the committee's recommendations, the sanctioned amount of ₹1,05,71,756/- stands released to SDM Karsog and the project stands completed.



Financial support for renovation work in Harihar Mandir, Vikasnagar

Harihar Mandir Nirman Samiti Vikasnagar, Shimla had requested for financial assistance for renovation work in Harihar Mandir building at Vikasnagar, Shimla. The temple discharges social services like free medicines to poor persons, organizing free health camps for older people through HelpAge India and organizing of cultural functions in its hall. A financial support of ₹7.00 lakhs has been extended to the Harihar Mandir Nirman Samiti.





Development of four Cultural Heritage Sites of Himachal Pradesh

The Government of Himachal Pradesh had requested SJVN to take up development of a few cultural heritage sites of national importance in Himachal Pradesh under "Apni Dharohar Apni Pehchan" drive of Government of India. Accordingly, SJVN adopted four heritage sites out of the 29 listed sites. An MOU was signed by SJVN Foundation with Department of Language and Culture (LAC), H.P. on 25.02.2019 for development of the following four sites at a total cost of ₹25.00 Lakh each.

1. Sapni Fort, Sangla, Kinnaur
2. Parshuram Temple Complex, Nirmand
3. Kalka-Shimla Railway heritage, Kalka, and
4. Chhitkul village, Kinnaur

a) Development of Sapni Fort, Sangla, Kinnaur

A proposal for financial assistance of ₹93.10 Lakhs had been received from Department of Language and Culture (LAC), Shimla for renovation/restoration work in Sapni Fort. Hence, after due deliberations and committee recommendations, SJVN Foundation has



Accordingly, a sanction letter dated 04.01.22 was issued to BDO Nirmand for executing the work in Parshuram Temple Kullu at a financial implication of ₹29.12 Lakh. Rampur HPS are the nodal agency for monitoring of the work which is under progress.

The proposal regarding development of Kalka-Shimla Railway heritage, Kalka, and Chhitkul village, Kinnaur are yet to be received from GoHP

released an amount of ₹50.00 lakhs to the Piri Killa Nirman Prabandhan Committee Sapni in two equal instalments of ₹25 Lakh each on 18.03.2020 and 27.11.2020 respectively. The work is under progress.

b) Development of Parshuram Temple Complex, Nirmand

Director, Department of LAC in their communication dated 09.12.21 has submitted a proposal for providing financial support to Parshuram temple for various developmental works in the temple complex.





Construction and repair of 'Anand Shikhar Sadhnalaya', Banuti, Shimla

Yogada Dhayan Kendra, The Ridge Shimla, runs a meditation centre at 'Anand Shikhar Sadhnalaya', situated at Banuti, Shimla. It is a spiritual retreat for the devotees who come together for regular group meditations and other spiritual activities. SJVN Foundation has extended a financial support of ₹14,47,926 for construction and repair works of the meditation centre. The amount has been released in 03 instalments to Yogoda Sansthan and the work stands completed.



Renovation and repair work at Chambu Devta Temple Complex at Jhakri

For the renovation and reconstruction of Chambu Devta temple complex at Jhakri, a financial support of ₹2.44 Crore was approved as a step to restore the cultural heritage of the area. The Foundation stone of the temple was laid by CMD, SJVN on 11.04.2019. The work was completed on 03.01.2022 and payment of ₹2.44 crore has been released.



Construction of Shri Kali Temple at Deonder, Chopal Shimla

A proposal for construction of the Shri Kali temple complex at Deondar, Tehsil Chaupal, District Shimla and railing work around the temple premises had been made by secretary, Shri Kali Temple. SJVN Foundation accepted to extend the required financial assistance of ₹50,54,197/- to the temple committee. The construction/renovation work is being done with the help of a registered architect. So far funds amounting to ₹40,43,356/- stand released to the temple in two installments. The work is under progress and the last payment will be released after receipt of utilization certificate.



Construction of Community Hall in Devta Kurgan Temple, Mashobra

Devta Kurgan Temple Management committee (Sanahu) is located in P/o Deola, Mashobra, Teh. Sunni, Distt. Shimla, H.P. The temple Secretary had requested for extending a financial support of ₹3,84,545/- for the construction of structural works (RCC) for the community Bhawan in the temple complex. SJVN Foundation extended the financial support requested in three installments for carrying out construction of structural works for the community Bhawan. The construction works have been completed and the Project stands closed now.





Construction of Tourist Shelter at Yatri Sadan at Churdhar

A request was received from Chairman, Chureshwar Sewa Samiti (Regd.) for construction of additional accommodation to Yatri Sadan (Tourist Shelter Home) for the pilgrims and tourists visiting the place at a financial implication of ₹58,48,103. It is expected that after the provision of additional accommodation at Yatri Sadan, the Samiti will be able to provide shelter to around 1200 pilgrims and tourists. SJVN has extended financial support of ₹72,12,000/- to Chureshwar Sewa Samiti for finishing the work of new Yatri Sadan (Tourist shelter home) and construction of attic floor of Yatri Sadan at Churdhar.



So far an amount of ₹57.68 lakh has been released to the agency in two installments. The final installment will be released after completion of work and submission of related documents. The work is in progress.

Renovation of Ashutosh Shiv Mandir, Shimla

A request had been received from Ashutosh Shiv Mandir Samiti, Shimla for construction of steel roof and boundary wall at a financial implication of ₹24,05,883. Accordingly, SJVN Foundation agreed to extend a financial support of ₹23,09,852/- to Ashutosh Shiv Mandir, New Shimla and conveyed the same on 09.09.2020. Further, the construction works have been completed at a financial implication of ₹22,95,727/- which was released to the temple samiti in three installments.



Construction of Community Bhawan at Shree Aadi Shakti Mahamaya temple, Kacheri, Shimla

A proposal seeking financial support for construction of community bhawan at Shree Aadi Shakti Mahamaya temple, Kacheri (Oddi), tehsil, Kumarsain, distt, Shimla (HP) was received. Accordingly, after committee recommendation, SJVN Foundation agreed to extend a financial support of ₹6.5 Lakhs out of the total estimated cost of ₹12.88 lakhs, for carrying out the work of erecting 08 RCC pillars and roofing work in the community bhawan. Accordingly, the work was completed and the full sanctioned amount of ₹6.50 Lakh released to the temple committee in three installments. The project stands closed now.





Installation of High Mast Light in Gawas temple, H.P

Secretary, Gram Panchayat, Gawas, Development Block, Chhohara, District, Shimla (HP) had requested for financial support for installation of High Mast Light in the Temple at an estimated cost of ₹3,59,083/-. Accordingly, the financial assistance of ₹3,59,083/- was released in favour of Gramin Vikas Sabha, Gawas, in two equal installments. The high mast light has since been installed in the temple premises and completion report and utilization certificate have been received. The project stands closed now.



Re-development of Sh. Badrinath Dham town as Spiritual Smart Hill Town, UK

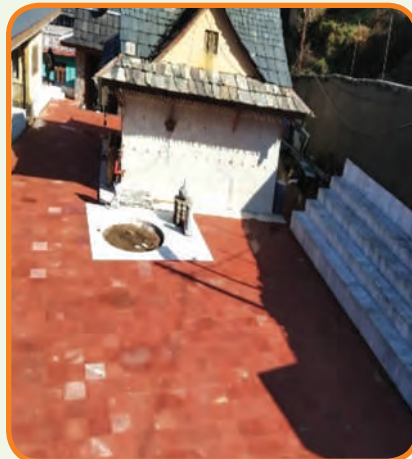
The Government of Uttarakhand (GoUK) has initiated the process of construction and re-development of Sh. Badrinath Dham as Spiritual Smart Hill Town in order to achieve the grand vision of Hon'ble Prime Minister of India. The development of smart town will facilitate comfort and safety of millions of tourists visiting the shrine and enrich their lives with unforgettable spiritual experience. The tentative estimate for the aforesaid project is ₹74.75 Crore and SJVN has consented to contribute ₹12.00 Crore.

MOU to this effect has been signed between SJVN and Secretary, Sh. Kedarnath Utthan Charitable Trust (SKUCT) on 16.03.2021 at Dehradun. Further, Secretary SKUCT vide letter dated 02.12.21 has submitted the final DPR to SJVN for ₹11.99 Crore instead of ₹12.00 Crore and accordingly, an amount of ₹466.27 Lakh has been released in 02 instalments. The work is under progress by GoUK.

Tiling/Flooring and Fencing of courtyard of Temples:

Tiling/Flooring and Fencing of courtyard/common area of temples in 4 No. villages in the Project Affected Area of Rampur HPS have been done for facilitating villager to organize traditional functions smoothly. Total 20000-30000 persons benefited per year. SJVN spent ₹24.00 Lakh during FY 2021-2022 for the following works:

- Laying stone flooring in Temple Complex of Iaxmi Narayan Temple, Gram Panchayat Bhadawali, Tehsil Rampur, Distt. Shimla (H.P).
- Laying of flooring in courtyard and erection of fencing near Temple complex of Devta Jharu Naag Temple at village Tunan, Gram Panchayat Tunan, Tehsil Nirmand, Distt. Kullu (H.P).
- Erection of fencing in Dakshineswar Mahadev Temple at village Nirmand, Tehsil Nirmand, Distt. Kullu (H.P).
- Erection of fencing and laying Kota Stone flooring around Devi Damsan temple at Village Shah, Gram Panchayat Kushwa, Tehsil Nirmand Distt. Kullu.





Support to other Cultural events

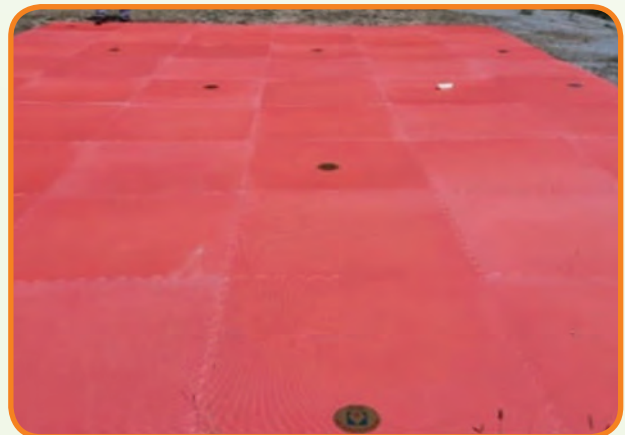
SUPPORTING THE SPORTS ACTIVITIES

State Rifle Association (HPSRA) has requested for financial support of ₹16.25 Lakh for installation of five Electronic Target Systems in 10m shooting range at Indira Gandhi State Sports Complex (IGSSC), Shimla. The HPSRA is affiliated to Department of Youth Services and Sports, HP and aims to promote the shooters of the state.



After examination of the proposal and with a view to provide state of the art sports infrastructure the financial support of ₹6.50 Lakhs for installation of two 10m Electronic Target Systems at Indira Gandhi State Sports Complex (@ ₹3.75 Lakh per system) was approved and consented on 15.09.2021. Accordingly, payment of ₹6.50 lakhs was released to HPSRA Shimla on 22.09.2021 for procurement and installation of Electronic Target Systems and work is completed by HPSRA with in scheduled time. The systems are being used by the shooters to prepare for national and international level competitions.

Support to National Ice Hockey Development Camp and 9th Women's National Ice Hockey Championship.

Addl. District Magistrate-Spiti Sub Division-cum-Chairman, Ice Hockey Association of Lahaul Spiti (IHALS), had requested for financial support of ₹18,52,625/- for organizing National Ice Hockey Development Camp and 9th Women's National Ice Hockey Championship-2021-22. The entire event was to be organized from 25th December 2021 to 20th January, 2022 in Kaza (Spiti).

The National Ice Hockey event, attracted around 80 participants from the states viz Ladakh, Jammu and Kashmir, Telangana, Maharashtra, Delhi etc. while around 20-25 participants from within the state of Himachal Pradesh. Winter sports in the area have always attracted huge potential, especially from the Himalayan region, which offers natural and favorable conditions for the sports. To facilitate the hosting of the national event and to popularize Ice Hockey among younger generations SJVN Foundation has extended the financial support of ₹15.00 lakhs to Ice Hockey Association of Lahaul Spiti (IHALS) and the funds were released on 05.01.2022. The event has been completed successfully.





Procurement of Sports items for Mahila Mandals and Yuvak Mandals of H.P

ASSISTANCE DURING NATURAL DISASTERS

Natural disasters make a significant impact on the public health and well-being of people affected. Negative health impacts can be direct (e.g., injuries) or indirect (e.g., malnutrition and increase in infectious diseases). In the aftermaths of a natural disaster, these health issues are compounded by the damage done to health systems, water and sanitation infrastructure, and the displacement of communities affected. Displacement is quite common after major natural disaster.



SJVN has always been in the forefront in providing relief assistance to the victims of natural calamities. The support is extended by providing relief materials, infrastructure support directly to the victims or through contributing to the Government funds such as State Disaster Management Funds, PM CARES Fund, etc.

Construction of fodder/ Wood storage room in sub division Mori, Purola, Uttarakhand

The Hon'ble Minister of State for Power, GOI had announced during stone laying ceremony of Naitwar Mori HEP in Uttarakhand that SJVN will provide a financial assistance of ₹15.00 Crore for construction of fodder shelters for the victims of a recent fire in local villages. Subsequently, an estimate of ₹13,28,20,269/- was received from Disaster Management Authority, district Uttarkashi for the financial support. The proposal for construction of fodder/ Wood storage room for 3579 families for the prevention of fires in traditional wooden houses of sub division Mori, Purola, Uttarakhand was consented vide a communication dated 13.12.2018. A MOU was later entered into with the District Administration by NMHEP on 15.01.2019. Further, DM Uttarkashi has decided in a meeting held on 05.01.2021 that after the completion of sheds in Project Affected area, no more sheds shall be constructed in other villages till further orders. Thus, only 1792 sheds shall be constructed / completed out of total 3579 sheds.

Till date ₹8.00 Crore have been released to GoUK, and 1151 sheds have been constructed so far. As desired by DM Uttarkashi the balance sheds are to be constructed on community basis. The work is under process.





Assistance for immediate relief to victims of Fire in Purbani village of District Kinnaur

On 23rd October, 2020 a sudden fire incident took place in village Purbani in District Kinnaur wherein 10 traditional wooden houses were completely burnt. The fire incident left 5 families (total 15 members) homeless as they did not have any other house to live. Besides these, 12 other persons (labour and carpenters) staying the village lost all their belongings and valuables. In this hour of dire need, SJVN Foundation provided immediate relief to the fire victims by providing basic daily need items like blankets, Quilt, mattresses, utensils, gas stoves and food items. An expenditure of ₹2,58,081/- was incurred on providing the various relief items.



Financial support to the Department of Disaster Management and Rehabilitation Govt. of Uttarakhand

To mitigate the loss and damages caused to the public and private infrastructure by a high magnitude quake that occurred in Uttarakhand on 17-18 October 2021, Disaster Management Department of Uttarakhand requested SJVN to extend the financial support to the State's CSR Fund for "Uttarakhand State Disaster Management Authority", which is a registered agency for undertaking CSR activities vide Ministry of Corporate Affairs, Govt. of India, order dated 28.10.2021.

In the times of such dire need and to extend a helping hand to the victims of this natural calamity, SJVN Foundation accorded a financial assistance of ₹50.00 lakhs to Disaster Management and Rehabilitation Department, Govt. of Uttarakhand.

Relief measures during flood in Bihar

During the disastrous flood in the areas of Bihar during Monsoon 2021, STPL distributed relief kit containing food packets, medicines, etc. in the flood affected area of affected Panchayats at a cost of ₹17.66 lakh.





Assistance during Landslide at Nigulsari, Kinnaur, H.P

On 11 August 2021, a massive landslide hit the national highway near Nigulsari village in District Kinnaur H.P causing damage to property and blocking strategically important Shimla-Kinnaur national highway. During the landslide a bus, a truck and 04 cars carrying about 50 passengers came under the rubble. SJVN instantly forayed into action provided all sort of help during the rescue mission. An expenditure of ₹7,60,547/- incurred during the rescue operation.



SJVN in combating COVID-19

COVID-19, the infectious disease considered as global pandemic by WHO, has tremendously disrupted the socio- economic conditions of entire world including India. SJVN being a socially responsible citizen rose to the occasion and started a number of pandemic combating measures. The MCA, Gol issued a notification that expenditure on COVID-19 will come under CSR expenditure. Even before the advisory issued by GOI, all office premises were disinfected on continuous basis and employees were informed to take cognizance of pandemic. All circulars issued by district administration were strictly adhered. To avoid congestion in office canteen, employees were advised to bring lunch from home. The office timing was also staggered.

Perceiving the seriousness of global pandemic at the very outset, SJVN immediately forayed into different relief and aid measures in its different project areas as well as in corporate office. A glimpse of SJVN contribution under its CSR arm SJVN Foundation in fighting the pandemic is as below:

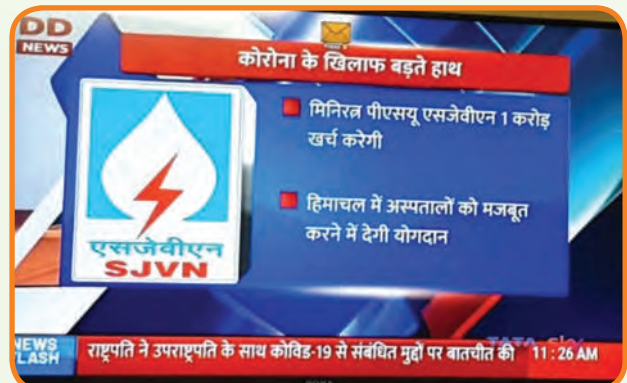




Boosting the Healthcare Infrastructure

- Procurement of 50 semi fowler beds with side rails, drip stand and cardiac table for IGMC Shimla
- Procurement of one COVID-19 Rapid Testing Machine for Civil Hospital, Uttarkashi, UK
- Procurement of cardiac monitor, oxygen concentrator etc. at Community Hospital Joginder Nagar H.P.
- Distribution of PPE Kits for IGMC Shimla, Mahatma Gandhi Hospital Rampur, Civil Hospital, Reckongpeo H.P., District Hospital Buxar and Medical Staff of MMUs.
- Procurement of Face Masks and sanitizer across all project locations of SJVN.
- Covid-19 awareness through radio, newspapers, banners etc.
- Deployment of Vehicles and Ambulance with Local Administration for COVID-19 duty.
- Financial Support towards purchase of 104 PPE Kits for 13 MMUs to HelpAge India

- Providing locally stitched cotton masks, food items, sanitizers in Project Affected Areas of SJVN.





Un-interrupted Medical Services at Doorstep through MMUs:

Since lockdown, SJVN has been continuously providing the medical treatment through its dedicated fleet of 14 Medical Mobile Units (MMUs) under the name of "Satluj Sanjeevani Sewa" for serving the local community at their doorsteps and also creating awareness among the masses. The medical staff of all 14 MMUs is equipped with PPE Kits and other safety equipment's for treatment of patients and as result we were able to continue to treat the patients. During the panic situation and chaos among local community due to the



novel virus COVID-19, the MMUs proved to be a life line for the needy, as well as in disseminating information about preventive measures and improving personal hygiene in far flung areas where providing basic facilities had become a big challenge during the lockdown. These MMUs were also used for regular thermal scanning of employees of SJVN, CISF and other people in the project affected areas. 104 PPE kits were also provided to HelpAge India for their staff deployed in MMU service.

DEVELOPMENT WORKS IN ASPIRATIONAL DISTRICT, CHAMBA

The programme 'Transformation of Aspirational Districts' was launched by the Centre which aims at quickly and effectively transforming these districts. The initiative has been taken for compressing the gap between developed and underdeveloped districts termed as Aspirational Districts. The GOI has formulated this initiative in January 2018 aiming to improve India's ranking under Human Development Index. SJVN has been allocated district Chamba on the directions of DPE under aspirational district program. Accordingly, SJVN approached district administration, Chamba for taking up developmental projects based on annual common CSR theme. The projects are being monitored jointly by SJVN and representatives of Dy. Commissioner, Chamba.

Due to outbreak of COVID-19, nationwide lockdown and state restrictions no new projects were sanctioned in the FY 2020-21 in the aspirational District Chamba. However, the already approved activities were continued in FY 2021-22 and the theme-wise detail of projects is as under:

THEME: "Health and Nutrition, with special focus on COVID related measures including setting up makeshift hospitals and temporary Covid Care facilities" for the FY 2021-22.

DPE vide OM dated 12.05.2021 has shared the national theme of FY 2021-22 for CSR expenditure i.e. "Health and Nutrition, with special focus on COVID related measures including setting up makeshift hospitals and temporary Covid Care facilities".

Further, DC Chamba vide letter no. 13466 dated 11.05.2021 has requested SJVN to provide the various medical items which are required by CMO, Chamba and Medical College Chamba to fight against COVID-19. Subsequently, on examination of the proposal by DSHEP sanction letter to DC Chamba for financial support of ₹39.73 Lakh was issued. 1st installment of 50% amount of ₹19.86 Lakh has been released to DC Chamba. The order has been placed through GeM and procurement is under process.

Health and Nutrition

DC Chamba has submitted a proposal for procurement for procurement and installation of 4D Ultrasound Machine at Medical College Chamba to improve the health facilities and better diagnosis of diseases. Accordingly, vide letter dt. 09.12.2021 SJVN Foundation has agreed to extend financial support of ₹1.00 Crore to DC Chamba for procurement and installation of 4D Ultrasound Machine at Medical College Chamba. The payment will be made in two equal installments of ₹50.00 Lakhs each, whereunder the 1st installment of ₹50.00 Lakhs has been released to DC Chamba on 04.02.2022 to start the procurement.

THEME: School Education, Healthcare and Nutrition (FY 2019-20)

The annual theme for FY 2019-20 was "School Education, Healthcare and Nutrition" accordingly SJVN has extended financial support to district administration, Chamba for infrastructure development in areas of School Education, Healthcare and Nutrition in the district. The support extended to DC, Chamba for the activities in the FY 2019-20 is being continued in FY 2021-22 and the component wise break-up of the items provided and their status and financial expenditure is as under:

THEME: School Education and Healthcare (FY 2018-19)

The annual theme for the year FY 2018-19 was School Education and Healthcare. The project taken up on the given theme in aspirational district, Chamba had started in FY 2019-20 and continued in FY 2020-21 and FY 2021-22. The detail of the project taken up are as under:

a. Construction of Schools Buildings:

SJVN with the support of district administration is constructing 17 primary school buildings situated in 10 blocks of district where school dropout is a common phenomenon due to absence of school in nearby location.

This project will benefit the schools of 10 remote blocks of District Chamba namely Sundla, Salooni, Chowari, Kallhel, Tissa, Hardaspura, Chamba, Gehra, Pangi and Bharmour. The initial total cost of this project was ₹261.66 Lakhs for construction of 17 Units @ ₹15.39 Lakh per Unit and each unit includes - 2 rooms with site development, playground, boundary wall, toilets and kitchen sheds. However, an additional amount of ₹34.26 Lakh was approved to be extended to DC Chamba on account of the school units falling in the remotest areas of the Distt. Chamba and involving head load carriage up to 5 to 6 KM from main approach road to actual construction sites, resulting in increase in the cost of construction.

The revised Project cost and the expenditure incurred so far are as under:

b. Health Infrastructure Project:

SJVN received proposal from District Administration, Chamba for following health care facilities with the overall cost of ₹139.80 Lakhs in the FY 2019-20 and accordingly SJVN had sanctioned the same. However due to the pandemic the works got delayed and hence, continued till FY 2021-22. Now the has been completed and status is as under:

SUCCESS STORIES

1. SUCCESS STORY OF MMU-II - DISTRICT - KINNAUR

- A. Bari is a small village/hamlet in Tehsil - Nichar in District Kinnaur of Himachal Pradesh. It is located 30KM towards west from District Headquarter Reckong Peo. The Nathpa Jhakri Hydro Power Station (NJHPS-1500 MW) is approx. 40 KM away from this village and lies under the affected area of the project. The case study is based on Smt. Inder Mani. She lives with her husband, son, daughter and two grandsons.

Smt. Inder Mani interacted with MHU in Nov 2016. But was also taking the treatment before interaction with MHU. According to Smt. Inder Mani, she is facing problem of Bronchial Asthma and Osteoarthritis of both knee joints hypertension and also peptic dyspepsia since last few year due to this she became very weak. She told that in the beginning she went to CHC Bhabanagar to take consultancy about her ill health. But due to unavailability of doctor, the para medical staff referred her to Rampur for proper check-up. She went to Rampur which is 65 KM. from Bari.

The MMU medical consultant advised her for adequate treatment and after taking proper medication, Smt. Inder Mani is healthy now and there is considerable improvement in her joint pain. She said that **“MMU operated by Nathpa Jhakri project is providing best health services in our area. Patients need not to go far away”**.



- B. Kashpo is a small village/hamlet in Nichar Tehsil in District Kinnaur of Himachal Pradesh State. It comes under Nichar Panchayat. The Nathpa Jhakri Hydro Project (NJHP-1500 MW) is 21 KM away from this village and this community under the affected area of the Project. So that the MHU providing their services last few years to this community. Mr Hari Singh is 70yr old. The patient is apparently normal before 10 ten years above, then he had developed small nodule on his right eye at medial canthus. He ignores it and does not taking any medical advice for that, then the primary lesion continue to grow and cover the whole eye with surrounding structure within 5-6 year then he start creeping pain sensation and bleeding through his Right eye then he go to CHC Rampur where doctor advise him for surgery.

Mr Hari Singh came into MHU in Oct 2016. He told his all past history to our Medical consultant. HelpAge medical health unit has done general physical examination, blood sugar, blood pressure and start symptomatic and preventive treatment for him.

According to Mr Hari Singh he feel healthy now. He said that MHU providing better health service in our area. Patients have not to go far away. He also said that this facility reach at door step of our areas and providing best health services for the people and persons not paid for it. He thanks Help Age India, SJVN MMU staff for this great initiative.

2. SUCCESS STORY OF MMU-I - DISTRICT- SHIMLA

- A. Sumi Devi, 70 years old and resident of Basara Village, which falls under Dhargaura panchayat of Tehsil Rampur Bushehar, Basara village is 20 km far from the HelpAge India Mobile Health Care Unit office.

Sumi Devi has one son and three daughters all are married her husband had passed away and she lives separately from her children and does agriculture work in her farm. According to Sumi Devi, she was unwell since last three months. On third Sept. 2020 she approached MMU with a complaint of backache and symptoms of anxiety such as lack of sleep at night and decreased appetite. On examination it was found that she was hypertensive her blood pressure level was (160/80). The mobile health unit consultant provided her appropriate medication and continued consulting her with regard to her health from time to time.

After regular examination, her anxiety was gone and blood pressure was back to normal 130/80. According to her, the Civil Hospital and PHC were far away from her village and it was very difficult for her to travel in bus and stand in queue of senior citizen for treatment. According to Sumi Devi, whenever she falls ill, she takes medicines from the mobile health unit. Now, she gets a quality health check-up at door step with free medicine. After regular checkup and continuous diagnosis, in her interview she said that:

She is very happy with the service provided by the Mobile Health Care Unit. Her blood pressure is under control now. She is very happy with MHU team and medicines and is also getting relief from the medicines provided by MHU. According to Sumi Devi, such health services should run in future also so that more people are benefitted.



- B. According to Mr. Raghveer, he has been coming to MHU for the last 6 years to get his health checkup and take medicines. He has benefited a lot from MHU, they are getting free medicines at their doorstep, they do not have to go to chemist's shop for medicines, due to which they save both money and time. Mr. Raghveer also said that he has benefited more from the MHU's health check-up, his health has been greatly borrowed and he is feeling good.

Mr. Raghveer Singh was found with a blood pressure problem in 2006 and was detected diabetic in 2008. This was diagnosed after he suffered symptoms like dryness in mouth, high heart rate, and increase in urination. He has been visiting the MHU van since it has been available in their area, from about 2014.

He also consults other doctors in Rampur (MGMC Khaneri) and Saharan, which is the closest medical facility to his village. He visits a specialist in Shimla in few months for a specialist consultation who recommends him to keep taking medicines from the MHU and suggests some medicines that he buys from Sarahan village.

He is a fit person and walks every day about 10 Km's return journey from his place.

Mr. Raghveer Singh highly appreciates the help that the Help Age team has provided him. Now he doesn't have to worry about sugar and Blood pressure levels because the team regularly keeps them in check and gives proper medical intervention when required. Also, whenever he has problems like fever, rash etc. they are cured with proper medical diagnoses by the MHU (Help Age India) Medical consultant.

Treatment Patient is a known case of DM2, HTN and BPH. MHU Medical consultant has prescribed medicines like: Enalapril 5mg, ODMetformin 500 mg and BDTamulosin 0.4 mg OD.





3. SJVN Physiotherapy Centres – A Boon For Patients

A. At project hospital, Bayal-RHPS

Hit by a paralytic stroke in January 2021, Yograj, a 40 year-old taxi driver from Nirmand village of Kullu, for eight months was bedridden and unable to even access the toilet. All family savings and borrowed money had been used up for treatments availed at Rampur, Solan and Chandigarh hospitals.

“He was brought to Physiotherapist centre at SJVN hospital Bayal on 9th September, 2021 in a completely disabled state,” Dr. Priyanka Sharma, the attending physiotherapist there. The distressed family had heard about a physiotherapy clinic operating at Bayal hospital which they decided to try out.

Financially exhausted, the patients wife approached the Bayal Hospitals authorities for help. A mobile medial unit (MMU) ambulance, run by SJVN, picked up the patient from his home and brought him free of charge to the physiotherapy clinic for treatment.

Put on a regular muscle building exercise schedule, within two months Yograj had been able to regain enough strength to move his paralysed leg and arm. “He can now independently go to the toilet” his wife said.

In a slurred voice, still damaged by the effects of the stroke, Yograj displayed confidence saying, “I’m much better now and will only get better.” To demonstrate his improved state, he rose from his bed unassisted and with the help of a walking stick limped around in the exercising room of the clinic. In a year Yograj hopes to be fit enough to earn a livelihood to support his wife and two small school going children.

The clinic has proved a boon for him and many other patients being treated at the two Physiotherapy centres being run by SJVN at Bayal and Jhakri hospitals.

During a span of 4 years, over 7000 patients suffering for arthritis, chronic backache, spinal or stiff neck problems, accident victims, sports injuries, post-operative patients needing exercising care, those suffering from back, shoulder or limb injuries and many other patients, till November, 2021 have availed physiotherapy services at the Bayal clinic.



B. Physiotherapy centre at project hospital - Jhakri – NJHPS

Encouraged by the response to the centre, in August 2021 another clinic was opened at SJVN's Jhakri hospital. In four months, till November 2021, 1500. Patents have been attended / treated so far.

Sheela Devi, a middle aged housewife from Jhakri, had undergone a knee replacement surgery, whereas Pushpa Devi, a 60 year-old lady from a village in Kinnaur, is suffering from chronic knee joint pain problems. The two ladies have been undergoing a light physical as well as weight assisted exercising schedule. In between ultrasonic heat therapy is also given.



According to Sheela “With the help of a walker, now I’m able to walk”. Earlier it was so painful that I would simply avoid it.

Pushpa, whose knee pain was so severe that she was unable to sleep “there is much comfort. I’m at least able to sleep now. “Improving the quality of lives of many patients, without the assistance of surgery or medicines, these physiotherapy clinics run by SJVN have built up a reputation as quality healthcare centres.





4. Weaving a Tradition, Empowering The People

Conserving the cultural heritage and participating in the community development of the region where ever SJVN has ventured to set up a project is a mandate that the company imbibed as its corporate social responsibility (CSR) since the start.

To promote Start-Up's, conserve a culture and empower the people with self-employment avenues, it was in 2019-20 that SJVN decided to train 200 people in weaving trades.



"Weaving was a way of life for every household in Kinnaur, but today there are very few people who can work on handlooms," says Sudarashana, a young lady from Kinnaurs'Chaura village.

By November 2021, four training camp sheld at Jeori, Bhava, Dehra and at Spillo village had been completed. The Jeori camp was held under the supervision of Nathpa-Jhakri Hydro Power Station, the Bhava camp under Rampur Hydropower Station, the Dehra camp under Luhri Hydro Electric Project and the Spillo camp under the jurisdiction of Jangi-Thopan Hydro Electric Project.



The trainees, mostly women, proved to be keen learners. Master weavers with HPSHC were engaged to impart the year-long training. The accommodation equipped with traditional handlooms was set up by SJVN. All trainees were given a monthly stipend and to get self-employed enterprise started after completion of the years training, all trainees were gifted the handlooms on which they had trained.

"The weaving training camp connected me with my roots," says Sudarashana. "Now I'm self-employed and regularly weave shawls, mufflers and other woollen garments. Not only I'm skilled now, but 'am also able to contribute towards the family income," she adds.

Sapna, another young lady from the Chaura village, beams with confidence at having started earning an income after getting trained at the weaving camp. "There is much demand for the products I make and all of them get sold in the village market itself," she says. Thankful for being handed the handloom to get started, Sapna now does earn a monthly income that ranges anywhere between Rs 10 to 15 thousand.

Mamta, a 32-year-old housewife, was one of the trainees at the Jeori camp. "Earlier I had much free time on my hands, but after this training conducted by SJVN, I enjoy weaving in my spare time," she says. "Working daily is improving my skill and is also helping me to earn an income," said Mamta.

Sonia, a graduate who trained at same Jeori camps as, "the training and the loom have got me busy. Now, I'm trying to upgrade my weaving skills so that finer designs can be crafted. Dimple, another housewife trainee, is proud to have started to contribute towards the household income.

Higher up in a Kinnaur valley at Spillo village, ten women and two men also completed their year-long weaving training camp in August, 2021.

This SJVN CSR initiative has found much resonance with many women in Satluj River valley basin. For Kinnauri women it is helping to revive and conserve a handicraft that was a source of livelihood for many generations, and for others it has empowered them with a skill which enables them to earn a decent income.



5. Bites from beneficiaries of Manav Mandir- Indian Association of Muscular Dystrophy, Solan (HP)

Pranjal has been suffering from Duchenne Muscular Dystrophy. He had been taken to various hospitals for the treatment but no satisfactory results were found. "The kind of reply I had been getting led me and my family under great stress" he said. "In 2020 I came to know about IAMD through Google. I was pleased to know that there is a rehab center for the patients of Muscular Dystrophy. I was not able to visit IAMD because of first Lock down. After a year I finally went to IAMD, known as Manav Mandir. I had not been able to walk for more than 2 years but after visiting the centre and getting the therapy, I am now able to stand. After undergoing hydrotherapy and Physiotherapy continuously for 4 months, I am able to walk 2-3 steps and my arms have also got some power. IAMD is truly very helpful in improving my inner strength and confidence. Thanks IAMD and SJVN".

I have been working in this hospital since last five years as a physiotherapist. IAMD is providing the required treatment to whomsoever is suffering from Muscular dystrophy and need a remedy. My most treasured experience here is talking to families of people with muscular dystrophy about their strong background stories. Seeing patients from throughout India and also from the neighboring countries, returning after getting the desired results brings me unparalleled joy. I am also grateful to the SJVN Foundation, who has, since the very beginning, helped to shape our dream project.





6. SJVN - Sincerely Sustaining Religious Culture and Traditions of Himachal Pradesh

Chambu Devta was always given prime importance in each and every pooja performed at the project by the company. It is also believed that with the blessings of Devta any bottleneck faced in project construction would be solved easily. Many believe that the project completion and smooth operations are due to the blessings of Chambu Devta.



Vishal Mehta, President of the Mandir Committee says that

the renovation work had been completed till March 2021 at a cost of about ₹2.7 crore which was largely funded by SJVN under its CSR works. He says that for bringing the temple to its present level, a lot of efforts had been made in architecture, planning, construction, sourcing of material and involvement of stone and wood carving specialists. Most of the material used, he says, is local and from other places in Himachal Pradesh. The carving artists were engaged from the village Chiragi. He further said that the main precinct of the temple will house Chambu Devta where he resides except in the winter months when the Devtas are shifted to Kothi, another adjacent building. Normally on 22nd April every year a religious fair is organized in the temple.

Chambu Devta temple is not the only one renovated by SJVN to its present glory, but many other temples in the villages surrounding its projects have been renovated by SJVN under its CSR arm. Jagdish Negi, Gram Pradhan of Kaphor village near Chaura, falling on Hindustan Tibet highway tells that the Hiramata Mata mandir in this village was in a dilapidated condition till SJVN came forward to help its renovation. He says that the Base boundary wall of the temple as well as the community hall have been renovated at a cost of ₹27 lac funded by SJVN. The beautiful temple stands conspicuously on the left bank of the river and is clearly visible from the national highway.

The 300 years old Koyla Devi temple in village Koyal, near 412 MW Rampur Hydro Power Station too has been renovated at a cost of ₹24.5 lac funded by SJVN. Kuldeep Singh, an official managing the temple affairs tells that this village temple was in a very dilapidated condition. Now with the help of SJVN the temple has a sprawling main entrance, a beautifully wooden carved outer precinct besides some other small structures. The temple also has been provided with solar lights and other facilities by SJVN.





7. SJVN Contributes Rs 50 Lakh For Uttarakhand Disaster Relief

To help Uttarakhand mitigate the damage done by unusually heavy rains that struck the hill state in October 2021, SJVN Foundation has contributed ₹50.00 lakh for disaster reconstruction works.

Besides SJVN, six other central public sector power companies have contributed towards reconstruction and restoration of government schools and health centres in the state.



On behalf of all the power CPSUs, Union Power Minister Shri RK Singh had recently presented the collective Rs 22.5 crore cheque to Shri DS Rawat, Uttarakhand Minister for Disaster Management at a function held in Delhi. The Uttarakhand chief minister Shri Pushkar Singh Dhami was virtually present on the occasion. The Minister of State for Power Shri Krishan Pal Gurjar, Union Secretary Power, Shri Alok Kumar and CMDs of Power CPSUs also attended the function.

The contribution was made from the CPSUs Corporate Social Responsibility (CSR) fund. It is to be used for the reconstruction and restoration of 478 schools spread across 8 districts (Bageshwar, Nanital, Udham Singh Nagar, Pauri, Chamoli, Almora, Champawat and Pithoragarh) and 28 health centres in 5 districts (Almora, Champawat, Udham Singh Nagar, Nanital, and Pithoragarh) in the state.

Other than SJVN, the Power PSUs who had contributed to the fund includes NTPC, REC, PFC, Powergrid, NHPC and THDC. Uttarakhand State Disaster Management Authority (USDMA) has been made the nodal agency to execute the project within a one and half years' time frame.

Unusually heavy rains had hit several parts of Uttarakhand on 17-18 October that had resulted in loss to many lives and caused severe damage to infrastructure which included public schools and health facilities of the state.





8. SJVN Helps 15 Sirmour Villages Meet Their Water Supply Needs

As many as 15 villages of district Sirmour having a population of about 1600 habitants have found a new source of water supply, courtesy SJVN funded check dam constructed over Gount Khad at a cost of ₹57.00 lakh.

Changes in the complex weather cycles are impacting the rural areas of Sirmaur in the Shivalik ranges of Himachal Pradesh too like other regions. The need for water continues to grow as sources dry up and regular irrigation facilities fail, bringing down agricultural production.

Conserving and storing water have therefore assumed great importance in the rural economy. Sensing the need, after the locals made a representation, public sector SJVN stepped in to mitigate the problem of a rural habitat near the district headquarters Nahan, H.P.

A survey of Gount Khad, a seasonal rivulet, was conducted for creating a small water storage check dam. SJVN came forward to fund construction of a 'Multi-Purpose Medium Height Check Dam' on the rivulet. It was a new initiative under its Corporate Social Responsibility (CSR) environment sustainability program.

Executed at a cost of ₹57.00 Lakh, the Gount Khad check dam is one of the first water conservation projects in the region. Funded by SJVN, the dam has been constructed by Jal Shakti Vibhag, Nahan, a government of Himachal Pradesh department. The dam was completed in October 2021 and the scheme has already been made operational.

In the first stage more than 15 villages, namely Nihog, Dhirath, Shiharad, Gasani, Gussan, Shathari, Chakli, Gount, Banama and Dadoga, etc having a population of about 1600 residents, were benefited with a better supply of drinking water.

The 3.25 meter-high, 30-meter-long dam has a capacity to hold as much as 50 lakh liters of water. There are at least six drinking water schemes, including the Lift Water Supply Scheme (LWSS) of Gount village and LWSS LOH Saroga Tikker village, on the downstream side of this dam.

Earlier, after a heavy rainfall, many water supply schemes would get affected by flood-like conditions, but construction of the dam now controls the downstream flooding in the rivulet besides storing water. Construction of this dam is also helping in recharging groundwater systems.

Other than augmenting the drinking water supply schemes, the storage dam would also provide irrigation facilities to about 3000 bighas of land in the second phase of the project. The belt grows crops of ginger, potato, tomato, corn, onion, garlic and green peas. A bounty harvest is only possible when the rains are timely and good for the farming community which is totally dependent on rain fed agriculture in the region.

"Construction of the dam has proved to be a boon for us," says Tulsi Ram, a resident of Gount village. "We only had a state-run irregular water supply that could not be relied upon in the summer months. Gount Khad dam has now made more water available on a regular basis and has tremendously improved our lives," he added.

For Sagar Singh, another farmer of Gount village, suffering from the changes in weather cycle because of effects of climate change, the check dam has given rise to hope. "Growing crops here had become very difficult as there were no rains when the crops needed water. The weather has changed. Now it does not rain but pours that damages the crops," says Sagar. For him and other farmers in the region, an irrigation facility that uses the storage dam waters had become an emergent need. "The irrigation facility will definitely improve our farm productivity," says Sagar. Other beneficiaries of the scheme also say that this project would help them fulfill their aspirations for local area development.

Safe and regular availability of water is important for public health, whether it is used for drinking, domestic use, food production, or recreational purposes. Improved water supply and sanitation, and better management of water resources will boost economic growth and can contribute towards poverty reduction. SJVN, under its Corporate Social Responsibility Policy, is committed to fulfilling such societal needs of rural communities.

Small measures, like SJVN's environment sustainability conservation check dam project in Himachal Pradesh, is helping rural communities to weather the damages to lives and livelihoods being brought about by global climate change patterns.

CLOSING REMARKS

For the financial year 2020-21, SJVN Foundation had been provided with a CSR budget of ₹42.67 Crore while the total budget spent shot up to ₹52.87 Crore. And in FY 2021-22, the SJVN foundation had been provided with CSR budget of ₹58.57 Crore against which the total amount of ₹51.67 Crore was spent on key activities under CSR verticals identified as per schedule VII of the Companies Act, 2013 and it was a matter of great satisfaction that the Foundation was able to meet the needs and aspiration of local population in and around the project areas.

In health and hygiene, the mobile medical units 'Satluj Sanjeevani Sewa' were able to reach out to as many as 1,50,489 patients spread across its project areas in the states of Himachal Pradesh, Uttarakhand, Bihar and Maharashtra during the year FY 2021-22. Currently, 14 MMUs are being operated through HelpAge India across the projects and since inception of the services, it has attended 10,74,411 patients.

As a measure to promote ancient Ayurveda based low-cost health-care system, SJVN decided to continue to organize health awareness-cum-lifestyle programs based on Ayurvedic system. Accordingly, 200 ayurvedic camps were organized during FY 2020-21 and 400 ayurvedic camps were organized during FY 2021-22 around the project areas through Bhartiya Dharohar

Apart from the above services, SJVN has also established healthcare facilities in its Projects. Dental clinic services and physiotherapy services are being offered to people around the projects in Bayal and Jhakri. These services are offering free treatment to all the people specially the elderly who suffer from muscular and joint issues due to old age and the hilly terrain they live in. All of them have widely acclaimed the services. This year more than 1372 patients were offered free dental care and 4239 patients were offered physiotherapy services through the project facilities.

SJVN has been regularly extending financial support to key medical institutions in upgrading their medical infrastructure. SJVN has provided financial support to Indian Association of Muscular Dystrophy (IAMD) for construction of an Integrated Muscular Dystrophy Centre at Solan, and also for construction of Rotary Ashray which is a shelter home for attendants of cancer patients

undergoing treatment in IGMC, Shimla.

Buxar Thermal Power Plant (BTTP), under SJVN CSR Initiatives for Healthcare Programmes and Swachhata activities, has successfully addressed the issue of availability of potable water for locals due to high contents of Arsenic metal in the lands of Buxar. Further, sanitary napkins vending machines and incinerators were installed at 20 different Government schools while installation of water ATMs is also under process by BTTP.

Deen Dayal Upadhyay SJVN Krishi Yojana is a scheme instituted by the Government of India to double the income of Farmers by 2022. In order to extend the facilities under the scheme to farmers in Himachal Pradesh, SJVN entered into MOU with Dr. Y.S. Parmar University of Horticulture and Floriculture, Nauni and CSK University Palampur, for imparting skill training to farmers in areas of new and scientific methods of cultivation in the year 2019-20. Around 7711 farmers have already been trained under the scheme during the past few years and the farmers have observed substantial improvement in their income. In FY 2021-22 a fresh MoU was executive with CSK University Palampur for imparting skill training to 1000 farmers out of which 750 farmers have been trained. Also, sanction letter was issued to Nauni University for organizing 06 no one day farmer camps at project area for 1500 farmer out of which 1250 farmers has been provided necessary training.

For promotion of education and adding motivation to school children in taking up higher studies, SJVN has been providing financial assistance to students in their higher studies under the SJVN Silver Jubilee Merit Scholarship Scheme since 2012. Due to pandemic the scheme placed on health and now the scholarship is being provided to 257 students cumulative of FY 2020-21 and FY 2021-22.

Under sustainable development, SJVN has been taking up the issues of Swachhata Hi Sewa through construction and maintenance of school toilets under 'swachh vidyalaya abhiyan' and observance of swachhata pakhwada. This year Swachhata Pakhwada was observed with great zeal and enthusiasm in all projects and offices of SJVN. Activities like Swachhata pledge, cleanliness drives, installation of dustbins etc. were undertaken. Apart from these the company has





also been undertaking activities like restoration of water bodies, installation of solar street lights etc. in its project areas, construction of multipurpose dams in Gount, H.P. Also, SJVN under Deen Dayal Upadhyay Yojna has successfully restored 07 bodies during FY 2021-22 out of 12 water bodies under taken for restoration. In addition, for sustainable development SJVN has been providing financial assistance of supply and installation of solar lights in the areas of presence.

Further, SJVN has been providing assistance in infrastructure building and other aids such as construction of community halls, construction of hostel blocks in Himachal Pradesh, National Law University (HPNLU), installation of grid connected Solar Power Plant in GHSS Munderi, Kannur, and Kerala, construction of ambulance and link roads in rural areas, development of parks, construction of shops in Sujampur H.P etc. Over the years SJVN has built and shaped thousands of infrastructures like school buildings, roads, public parks, crematoriums, check dams, playground etc. In this area, as many as 93 community assets were taken up for construction in the project areas cumulative of FY 2020-21 and FY 2021-22. Out of 93 community assets 52 have been completed in FY 2021-22.

To promote and preserve the local culture, the company has been supporting and renovating temples of local importance such as Bhimakali, Tara Mata temple, Chambe Devta Temple, Shri Kali Temple, etc. SJVN has also adopted four heritage sites of cultural importance in Himachal Pradesh which include Sapani Fort, Sangla, Kinnaur, Parshuram Temple complex, Nirmand, Kalka-Shimla Railway, Kalpa and Chhitkul village, Kinnaur. Also, in the FY 2021-22, SJVN Foundation provided support to various sports activities such as National Ice Hockey development camp, 9th Women National Ice Hockey Championship, kabaddi and wrestling match to GSSS Cheog,

Shimla H.P, construction of badminton court in Buxar, Bihar, installation of electronic target system in shooting range at Indira Gandhi State Sports Complex, Shimla etc.

This year, under assistance during natural disasters, the company has contributed to Department of Disaster Management and Rehabilitation GoUK and also undertaken construction of fodder/Wood storage rooms for victims of fire in local village of Uttarkashi districts in Uttarakhand. In addition, SJVN has also provided support for relief to the fire victims of purbani village, Kinnaur H.P and flood victims in Buxar, Bihar. Also, SJVN has provided every sort of support for rescue operation during landslide in Nigulsari, Kinnaur, H.P.

The company had taken a special initiative out of its CSR budget to provide funds for combating sudden outbreak of novel CORONA virus, for which it has provided liberal assistance to medical institutions and its staffs through medical infrastructure support and protective gears such as mask, PPE kits, gloves and sanitizers.

Apart from the activities undertaken under the identified verticals, many other activities were also undertaken by the company this year. SJVN has taken up district Chamba under 'aspirational district programs' where it has taken up activities such as School Education, Healthcare and Nutrition, combating Covid-19 etc. The infrastructure facilities being provided include creation of school buildings in remote blocks, setting of library and different medical infrastructure like mobile van etc.

SJVN and its CSR SJVN Foundation will continue to stand by the society to make it a better place to live. For the year 2022-23, SJVN Foundation has been provided with a budget of ₹53.23 Crore for undertaking various ongoing and new activities.
