The detail computation of active energy is carried out by SLDC and block wise computations and meter data is published on website.				
2	Reactive energy supplied to Wind Farm pooling substation 220KV SADLA (INOX) S/S S/S is computed as per the conventional tariff meters. The detail computation of reactive energy is carried out by GEDA and circulated by them to all wind owners in advance.				
3	Share of wind Farms in the electricity received at interface point from 220KV SADLA (INOX) S/S S/S is computed by GEDA on the basis of energy generation recorded on each wind energy generation during the period specified as above.				
4	After careful consideration of various representation received before SLDC-Gujarat, SLDC has issued this statement for immediate period to circumvent difficulties faced by various wind owners. This will be continued till the received mechanism is in place. The any change in procedure will be communicated separately.
